### Question 9:

Is there a clear definition of what the Government means by intersectional gender-based issues. As there was an explanation for energy efficiency but not what is expected from the words intersectional genderbased issues. To some this can mean asking for sexual, gender and romantic identities to truly understand intersectional gender-based issues, whereas others interpretation would be different due to less knowledge on the 2SLGBTQIA+ spectrums. So just looking for clarification on what is meant for intersectional gender-based. As the definition can impact the study set up, especially as many people interchange gender and sexual identity, or end up excluding 2SLGBTQIA+ individuals and therefore don't get proper representation for data collection, results and recommendations.

## Answer 9:

More information on the definition of intersectional gender based issues and the multiple intersecting identity factors that make up the full identities of people of different genders, including sexual orientation and gender identity, can be found in the Government of Canada's GBA+ guidelines and resources listed. As per the Government of Canada's GBA+ resources (listed in this RFP) "Gender-based Analysis Plus (GBA+) isn't only about gender, and groups of people are not homogenous. Our experiences are affected by intersecting parts of our identity, the context we are in and our lived realities. We all have multiple identity factors that intersect to make us who we are. This is called intersectionality. The "plus" highlights the fact that GBA has always gone beyond sex and gender. It examines how sex and gender intersect with other identities such as: race, ethnicity, religion, age and mental or physical disability.

# Question 10:

Is the goal of this research to analyze current policies and procedures and the issues in them currently or is it more to develop a plan for what may arise? Or a combination of the 2? Is the target for the government for their energy plans or for government regulations for businesses to follow since much of the energy sector is private and many of the issues could be found to be in the business structures, which would affect the proposal plan for the study.

# Answer 10:

Section 2.0 explains "This requirement will support the OEE with reliable, consistent data and information on intersectional gender-based issues related to energy efficiency across Canada". Section 3.0 explains the further objectives of this research. As stated, "the report will be used within DPAD as a resource to more fully integrate GBA+ into policy development." In section 4.1, some considerations listed that can be part of the intersectional gender-based issues identified are "financial/income barriers (ability to purchase energy efficiency services, technologies and products), access barriers (ability to participate in energy efficiency policies and programs), social barriers, information barriers, employment barriers, and other types of barriers". Barriers as a result of business structures in the energy sector or as a result of current policies and procedures could fall under this description.

# Question 11:

Do the evaluation criteria M1 and M2 need to be demonstrated by an organization's experience or only by the team members' experience? For example, would a research conducted by one individual consultant (presented as partner) count as a valid experience?



#### Answer 11:

Please refer to answers #3 and #8 of RFP amendment #1. Your example would not apply. #### Question 12:
