In accordance with Part 2 – Article 2.4 – Enquiries – Bid Solicitation, this question and the corresponding answer are provided to all Suppliers.

QUESTION AND ANSWER

Question 1

Our question refers to Part 4 – Evaluation Procedures and Basis of Selection, section 4.1.5 – Financial Evaluation and Part 7 – Resulting Contract Clauses, section 7.6.3 – Method of Payment.

It is mentioned that payment will be made upon completion and delivery of services in accordance with the schedule of payment and with the payment provisions of the contract.

No description of the expected services is presented in the invitation other than the following services: Assessment of employability needs and establishment of an action plan and support for job retention.

Considering that :

- Emploi-Québec is the body responsible for the provision of public employment services to the citizens of Quebec;
- Emploi-Québec is already funding through service agreements with partners who have specialized expertise with offender clients (under federal and provincial jurisdiction) for employment services in the community similar to those described in this Bid Solicitation.

Should the Bidder's Financial Bid provide that the clients who will be served under this contract with the Correctional Services of Canada (CSC) will also be eligible and therefore partially funded via Emploi-Québec (EQ) for this clientele allowing them to have access to other services required in job search and to participation allowances, transportation costs offered by EQ or are all cost incurred for these various services required for the targets for each of the sectors will have to be invoiced to CSC?

Answer 1
