## AMENDMENT 003

Amendment 003 has been created to answer the following questions:

**Question 1: Under 3:1, "Bid Preparation Instructions": Are there any specific guidelines to follow in order to, in complete detail, explain and demonstrate how bidders propose to meet the requirements?**

**Answer:** Complete Annex A, if suggesting alternative part, indicate part number, supplier etc. Include a technical data sheet and indicate how suggested part would ensure compatibility, interoperability and interchangeability with existing equipment owned by Canada.

**Question 2: Under 4.1.1.2, "Evaluation Procedures for Equivalent Products": For bidders using equivalent products, is it okay to include an equivalent product specification at this time, providing the PN & NCAGE upon request during the evaluation period or should the PN & NCAGE be included with bid submission?**

**Answer:** Bidders submitting equivalent product(s) must include the equivalent's specification(s), PN and NCAGE with bid submission otherwise they will be non-compliant.

**Question 3: Should we also complete and submit the RFP (Request for Proposal Form)?**

**Answer:** Yes

**Question 4: For the neutral disinfectant liquid, is it 75 cases of 4x4L or 75 units each?**

**Answer:** 75 cases of 4x3.78 liters
