#### 2.1 Question No. 7

#### Question:

Below Envelop opening Flap logo will use or not ASP(?) art work design , This print logo use flap inside or outside kindly advise and share pure design and measurements .



#### Answer:

The logo that is printed on the flap will be centered on the flap as shown in the image. A print-ready PDF file, showing the exact measurements, will be sent to the winning bidder upon issuance of the contract. The logo is printed on the outside of the flap. As for the packaging boxes, the winning supplier can choose the dimensions of the boxes as long as they do not exceed 35lbs and are labeled as per the specifications.

#### 2.2 Question No. 8

#### **Question:**

Is that possible to extend the delivery from November 5, 2020, to January 7? Actually we would ideally need 90 days to produce a batch of envelopes and ship them to a location. Also due to exceptional circumstances of COVID-19, there are lots of global shipping/transportation issues.


#### Answer:
