AMENDMENT NO. 003

This amendment is raised to answer Bidders' questions.

QUESTIONS AND ANSWERS:

Question 11:

MTC1 requires two separate IM/IT contracts in the last five years that meet the strict criteria outlined in (a) to (f). Given that contracts of this nature are relatively rare, requiring two separate contracts will limit the pool of qualified bidders. In order to ensure a competitive procurement process, will ESDC reduce the number of contracts required in MTC1 to one?

Answer 11:

Your recommendation was considered but MTC1 will remain unchanged.

Question 12:

RE: RTC1: Bidder's Corporate Experience Providing Additional Application Resources states:

"In order to obtain the points allotted, using IM/IT contracts which provided Application Services for clients as described in Annex A Statement of Work (SOW) of this requirement, the Bidder must demonstrate the number of resources provided within the last 5 years as of the bid solicitation publication date for each resource category."

As written, RTC1 currently has no limitation to the number of contracts that Bidders can use for substantiation. This could result in the Crown evaluating as many as 34 different reference contracts per response. In a scenario where the Crown receives 10 compliant bids (which, in our experience over the last 6-12 months, is the average for GoC procurements), this could result in the Crown evaluating as many as 340 reference contracts. The impact to the Crown in this scenario would be an unreasonable and unnecessary level of effort and a significant delay in contract award.

To reduce the amount of effort required to evaluate and time to award for this contract, please confirm that the Crown will amend RTC1 to limit Bidders to using a maximum of **fifteen (15)** reference contracts. This change would have the additional benefit of ensuring that all successful Bidders have demonstrated experience providing teams of relevant resources, which aligns to the purpose of this RFP.

Answer 12:

Your recommendation was considered but RTC1 will remain unchanged.

Question 13:

We are a Tier 2 qualified supplier and have all of the listed categories. However we have 2 different supply arrangements and one of them is missing 1 category. It is certainly harsh requirement to ask the supplier to be qualified in all of the categories in order to submit a bid.

Is it possible to add some flexibility to have maybe 90% of the categories instead of all or maybe issuing multiple contracts.

Asking for all of the categories seem to indicate favouritism towards the incumbents.

Answer 13:

ESDC has a requirement for all the resource categories and therefore will not change the number of required categories. At the time of publishing this RFP, there were over 100 qualified TBIPS SA Holders.

"The Bidder must provide a designated Client Manager, including name and position title, with demonstrated experience providing contract management services to clients for a minimum of 2 years in the last 5 years as of the bid solicitation publication date."

In order to ensure successful bidders demonstrated ongoing commitment and continuous improvement to the management of the contract, would the client insert a requirement for the bidder's Client Manager to have successfully completed applicable staffing and recruitment certifications such as:

- Certified Temporary Staffing Specialist (CTS)
- Certified Personnel Consultant (CPC)
- Green Belt Recruiter (iPASS)
- Certified Staffing Professional (CSP)
