AMENDMENT 2

This amendment is issued in response to the following questions.

1. Further to the recent Amendment No. 1, regarding line item 25 High Pressure Wash Unit, is it the intent to not evaluate that item or will there be a requirement to input a unit rate ? If so what is the Unit of Measure (UOM)?

Answer:

Unit of measure will be an hourly rental rate and use a quantity of 20 hours annually. Although infrequently used, would like to include as part of the evaluation.

2. Regarding Items No. 1, 2 and 3 (oily bilge water, waste water sewage and waste oily water); Please clarify if the requested Unit Price is a disposal number only with the associated equipment rentals applicable, or is it the intention for this rate to be a bundled rate inclusive of disposal, offsite transportation to the disposal location and on site labor and equipment?

Answer:

Historically, this is a price per litre to remove contaminated water from the vessels.

3. Regarding Equipment Rentals item #30 (Freight Liner); please clarify if this referred to equipment is the "tank trailer" referred to in the Statement of Work.

Answer:

This is a tanker truck used for temporary storage or transportation of fuel from one site to another. An example would be when bunker C fuel was transferred to the Atlantic Vision from the Leif Ericson to prepare the Ericson for conversion to marine diesel fuel.

All other terms and conditions remain unchanged.
