Questions and Answers

- Q16. 1. To satisfy Managerial Criteria 4.3.1.1 – Team Expertise: will Canada deem Letters of Intent acceptable to support early identification of science team engagement?
2. Per C.2 Preliminary Requirements – Physical Requirements: could Canada please confirm that M-PHY-SI-004 Requirement should read: "Power consumption must be minimized" and comment: "The science instrument power requirements must be defined during the course of the contract and will become a requirement for next phases."
3. For Section 3.1.3.7 – Preliminary Commercialization Plan: can Canada please comment on the value of the optional Preliminary Commercialization Plan section to the Canadian Space Agency and the LEAP program?
4. For Section 3.1.3.7 – Preliminary Commercialization Plan: How does the optional Preliminary Commercialization Plan factor into overall evaluation/scoring of bid?
5. For Section 3.1.3.7 – Preliminary Commercialization Plan: Given business sensitive information could be included in the optional Preliminary Commercialization Plan, what will Canada use the content in this section for (current and future)?
6. Per the Price Breakdown 3.1.1.1. b) Equipment: "These items will be deliverable to Canada upon completion of the contract." Should the applicable equipment procured planned to be used for future Phases, what accommodations would Canada entertain?
7. General: What level of pre-investment within this Phase 0 SOW, is acceptable to Canada to support pre-Phase A/Phase A activities?
- A16. 1. Yes, letters of intent are acceptable to support early identification of science team engagement. As indicated in Attachment 1 to Part 3 Technical and Managerial Bid Preparation Instructions, Section 4.3.1.1. Team Expertise states the following: "Potential partners and/or stakeholders for the Phase 0 should be identified and letters of intent from these should be provided in the Bid."
2. We confirm that the requirement and comment are inverted.

3. The submission of a Preliminary Commercialization Plan is optional and will not be subject to the Point Rated Evaluation Criteria as per Attachment 1 to Part 4. If provided by the Bidder, then it may be used internally at the CSA to assist in the assessment of any potential future phases of the project.

6. In accordance with General Condition - Research & Development 2040 25 (2008-05-12), Government Property, the equipment is typically delivered to Canada upon completion of the Contract since it has been paid for and is considered Government Property. If it is required for subsequent phases of the project, Canada may supply the equipment to the Contractor as Government Furnished Equipment (GFE) but this is assessed on a case by case basis.
7. Canada will conduct the evaluation of the bid in accordance with Point Rated Evaluation Criteria as per Attachment 1 to Part 4. In regards to the LEAP Phase 0 Science Instruments SOW, please refer to article 3.1.5 Cost Estimate which specifies the activities that will be part of the Phase 0 SOW.

Q17. I am preparing a Statement-of-Work for the LEAP Science Instruments (9F050-200032/B) call. I cannot, however, find any instructions or CSA forms in this regard. Would you please advise how I can proceed with this application?

A17. The bid solicitation document, including Attachment 1 to Part 3 Technical and Managerial Bid Preparation Instructions, provides bidders with instructions on how to prepare their bid. Please refer to the bid solicitation document posted on BuyandSell.gc.ca for further details.
