The following changes in the tender documents are effective immediately. This Addendum will form part of the contract documents.

Bidder Questions:

Question #1: Based on review of the Summary of Work Specifications: Section 1.4, Line number 1.4.1.2.3 includes soil sampling (see below). There was no further information contained in the tender documents related to soil sampling. Can you provide guidance on soil sampling requirements?

1.4. Items covered in Specifications

- 1.4.1. Work to be performed under the Contract includes, but is not limited to, the following items, including all ancillary Work, covered further in the Contract:
 - 1.4.1.1. Mobilization of all equipment to a Starting Site as indicated. Onward movement to a series of sites as indicated which will be drilled as they are prepared and not in a linear geographical order. The drilling portion of the work will end at the Final Drilling Site as indicated.
 - 1.4.1.2. Environmental drilling:
 - 1.4.1.2.1. Borehole drilling.
 - 1.4.1.2.2. Well installation and completion.
 - 1.4.1.2.3. Soil sampling.
 - 1.4.1.2.4. Vapour probe installation.
 - 1.4.1.3. Management of contaminated soil and water
 - 1.4.1.3.1. Containment and disposal of contaminated soil cuttings:
 - 1.4.1.3.2. Supply of barrels for containment of contaminated water.
 - 1.4.1.3.3. Disposal of contaminated groundwater purged from wells by others during well sampling following well installation.
 - 1.4.1.3.4. Material identified, by Departmental Representative, as not contaminated may be used as backfill.

Answer #1: Soil sampling method and interval will be specified by the Departmental Representative prior to and during drilling (see para 3.1 on page 58 of 61). Sampling will be paid as part of Drill Rig Operation (see para 3.2 on page 59 of 61). Specific Sampling requirements are specified in Para 3.10 on page 60 of 61) sampling methods were not described in the specification documents. Sampling methods are drilling industry standard methods and include 50mm and 75mm nominal diameter split spoon's, auger flight samples and sonic cores.

Question #2: The specifications describes "other contracts" the may be currently in progress at these Sites (See 1.7 below). Will additional environmental consulting services and/or other future contracts be awarded? Is this related to question #1 above and is there a separate tender document that will be issued or has been issued for these sites that contain environmental consulting services?

1.7. Other Contracts

- 1.7.1. Other contracts may currently be in progress at Sites.
- 1.7.2. Other contracts may include:
 - 1.7.2.1. Environmental and other consultants.
 - 1.7.2.2. Owners and operators of active sites.
 - 1.7.2.3. Site users as identified in Contract Documents.
- 1.7.3. Further contracts may be awarded while the Contract is in progress.
- 1.7.4. Cooperate with other contractors in carrying out their respective works and carry out directions from Departmental Representative.
- 1.7.5. Coordinate Work with that of other contractors. If any part of Work under the Contract depends on its proper execution or result upon Work of another contractor, report promptly to Departmental Representative, verbally and in writing, any defects which can interfere with proper execution of this Work.

Answer #2: This clause refers to other work related to or independent of this contract that may be occurring nearby or on the same site, we are asking the successful bidder to cooperate accordingly to ensure all parties are able to complete their required tasks.

Question #3: As part of the Sonic Drilling Unit Price, will the contractor be expected to provide the water required for drill operations?

Answer #3: Yes, as part of the bid price for line items 9.2 and 22.2, the successful bidder will be required to provide and transport all required water to site for the operation. The Departmental Representative may provide a water license withdrawal permit for various locations along the Alaska Highway to assist in procuring the water.

Question #4: Can we qualify, modify or place conditions on items in our bid?

Answer #4: No. ANY qualifiers, modifications or conditions on items in bids will result in disqualification of the bid.
