PART 1 - GENERAL INFORMATION

1.1 Statement of Requirement

1.1.1 The requirement is detailed under Annex "A" of the resulting contract clauses.

1.2 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

PART 2 - BIDDER INSTRUCTIONS

Note: Bids will not be accepted if emailed directly to this email address. This email address is to be used to open an epost Connect conversation, as detailed in Standard Instructions [2003](#), or to send bids through an epost Connect message if the bidder is using its own licensing agreement for epost Connect.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 5 (FIVE) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Newfoundland and Labrador.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

2.5 Bid Challenge and Recourse Mechanisms

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of hard copy of their bid:

ANNEX "A" - STATEMENT OF REQUIREMENT

General

Background

The NRC's Ocean, Coastal and River Engineering (OCRE) Research Centre delivers innovative technologies and support to improve Canada's competitiveness by reducing risks and costs of marine operations while ensuring the safe and responsible development of marine-based resources. We provide the expertise and tools to improve the performance and safety of marine operations, meet the challenges of a changing climate, and protect people, property and infrastructure from severe weather events and other environmental risks. Our suite of offerings include physical and numerical modelling, engineering analysis, technology development as well as full scale experiments and field work conducted with the support of world-class test facilities capable of reproducing a wide range of ice, wave, current and wind conditions.

Project Description

NRC is implementing a new capability for the existing ice tank. We are creating the ability to model a river system with the assistance of a flume structure. This will give the NRC the ability to investigate the effects of frazil ice on river systems and equipment that is in use within those river systems. The addition of the flume structure will consist of wall structure only that will use the existing ice tank floor and walls as part of the flume design. There is no need to waterproof the connection between the corrugated flume structure and existing ice tank structure because the whole tank will be filled with water.

Confidentiality and Intellectual Property

Information exchanged as part of this project is to be treated confidential. Therefore, none of the parties shall divulge, unless in agreement and authorized by both parties any information identified as CONFIDENTIAL or PROPRIETARY. General

The proponent shall review the drawings and the associated pictures of end closure fittings to provide the best economical solution to supply the flume structure materials required. It is mandatory that the materials would be of the latest modern technology – developed within the past ten (10) years, using environmentally friendly techniques, while retaining functional capabilities.

Deliverables

The proponent shall provide the following by referencing the documentation in section 2.2:

- Multi-plate corrugated material to construct the flume wall structure in reference to drawing titled “Inner Corrugation”. The total area required is equal to 354.47 square metres.
- End closure fittings to close off corrugation material on the 6 meter radius ends of the flume structure. This part of the flume structure will connect to existing tank wall and must transition from corrugation to the flat wall. (See photos ECF_001,002, and 003 and End Closure Fitting DWG).
- The multi-plate material must have corrugation running in the horizontal direction, parallel with the existing tank floor.
- Each multi-plate section must measure 10 feet high.
- All multi-plate material must be made of 3 millimeter thick steel and have a corrosion resistant coating comprised of a zinc rich layer and a final polymer coating that is environmentally

friendly, Ethylene Acrylic Acid (EAA) is preferred. A material comprised of exposed galvanized surface will not be accepted.

- All appropriate hardware to be supplied for the assembly of multi-plate panels, for example nut and bolt. As well as holes pre-drilled in the multi-plate, ready for assembly.
- All multi-plate panels must be pre-bent for the end radius of the island portion (3 meter radius) and the flume end structure (6 meter radius). See reference drawings.
- All bidders must provide documentation within their technical bid, proving they meet all requirements.
- - 1. End closure fittings = 40 feet or 12.2 metres required.
 - 2. Straight multi-plate = 182.5 metres squared
 - 3. Curved multi-plate (3m radius) = 57.5 metres squared
 - 4. Curved multi-plate (6m radius) = 114.7 metres squared
- Shipping to the NRC location in St. John's, NL must be included in the price.
