Amendment 001

This amendment is raised to publish questions and answers as follow:

Q1: In section A2.2, it is mentioned that the distance between the harpoons of the cranes (stoplog lifters) is more or less the same (Quebec 6150mm and Ontario 6100mm). Is it necessary to have an adjustment on the spreader beam for the spacing of the harpoons? Would a fixed spacing be acceptable?

A1: Note that, as mentioned in the TSOR in section A3.3 point 2), the dimensions in the TSOR are not precise enough for the final design. Contract Task No. 2 (Obtain Field Data) exists so that the contractor can finalize the details.

The difference in spacing between the harpoons on Quebec and Ontario stoplog lifters is not large, but it must be taken into consideration in the design of the spreader beam. If the spreader beam's harpoons do not fit into the pockets, the spreader beam cannot be used.

There are a number of potentially effective approaches to solving this problem, and we have no preference between them.

Q2: Does the measurement of 5985-6000 in Figure #18 apply to joists in Quebec and also those in Ontario?

A2: Yes

All other terms and conditions remain unchanged.
