Amendment No. 002

This amendment is being raised to provide responses to Requests for Clarification.

1) REQUESTS FOR CLARIFICATION

Q11. As PWGSC has revised the Price Form and added Hydrologist/Hydrogeologist, will PWGSC consider Hydrologist/Hydrogeologist as senior/intermediate project staff for CV submission purposes (maximum of two CVs for senior personnel and project personnel each) or do the CVs have to be for engineers only as indicated in Sections 3.2.4 and 3.2.5 of the RFSO?

R11. No, PWGSC will not consider Hydrologist/Hydrogeologist as senior/intermediate project staff for CV submission purposes in Submission and Requirements Evaluation (SRE) Sections 3.2.4 and 3.2.5. The Senior and Project Personnel required for SRE 3.2.4 and 3.2.5. should be engineers only.

Q12. Please provide additional information such as bar diameter or plate thickness and material type for 2.12 Coupons for both tensile and chemical testing (3 coupons per test) under 4. Laboratory Services in Appendix B – Price Offer.

R12. Material type for coupon tests is Steel. Bar diameter up to 25 mm and Plate thickness up to 20 mm.

Q13. The General Requirements for the Hypothetical Project mention that “The roadway, bridge approaches and abutments need to be built over a marsh land”. Please clarify what it means by this, i.e., by ‘built over’ does it mean that infrastructure is allowed to be built on top of the marsh land or does it mean that the infrastructure has to go over (above) the marsh land – no construction allowed in the marsh land.

R13. Proponents need to answer this question and recommend a viable engineering solution based on the information provided. Sufficient information has been provided under the Hypothetical Project for Proponents to formulate alternative options and solutions. Proponents may make reasonable engineering assumptions if any information is missing and necessary in their engineering judgment.

All other terms and conditions of the solicitation remain the same.
