Questions and Answers:

-When is the planned start date for Task 2?

As per the SOW, the vendor is requested to supply a schedule within 14 days of contract award, including Task 2.
Please see: Annex A – Statement of Work – Section A4.1; Section A5.2
The date will be after the dam is out for the season, which is approximately the first week of November 2020.

-In order to determine the expected condition of the gearbox, when were the pictures in the Annex A taken? Can you share more pictures?

The photos were taken in 2019; there are no other useful pictures to be shared.

-Are the pocket wheels to be replaced? Does St Andrews have replacements?

They are to be cleaned and machined to specifications;
No, St Andrews Lock and Dam (SALD) does not have replacements.

-Are the pillowblocks to be replaced?

As per Annex A – Statement of Work – Section A4.5.4 (Task 5) : *“Based on the results of the previous overhaul of the gearbox assembly on the main frame crane, we expect that the work may include but need not be limited to items such as the following: (Sub Item #2) replacement of pillow block bearings, possibly including custom machining to get new parts to fit mounting points”*

Regarding Task 6:

-What are the sizes of the reservoirs?

About 80 - 100 liters

-Clean out access ? top or sides?

Top

-What are the access cover dimensions

10.5” by 10’.5”

-Can you provide pictures and/or schematics of HPU?

No schematics, however a picture is being provided.

-Customer to provide new filters, oil?

Vendor to provide all needed tools, parts, labour and supplies.

-Who is supplying tote/barrels for used oil?

Vendor to provide all needed tools, parts, labour and supplies.

-Is there any training/orientation (fall arrest, site orientation, rigging)?

SALD crew will operate the Overhead crane to remove unit from the center deck to ground level. We will also have a safety meeting with the vendor regarding hazards and the environment.

-Is there access to bring equipment/tools?

Yes, there is space to bring equipment & tools, however work is primarily going to be performed in the vendor’s shop.

-What is the available power?

There will be access to 110 volt plugs.
