The following revisions supersede the information contained in the original drawings and specifications issued for the above named project to the extent referenced and shall become a part thereof.

## **GENERAL**

This addendum is issued prior to receipt of Bids to provide for certain revisions to and clarification to the Contract Documents.

The work required by this Addendum shall be executed in accordance with the requirements of the Contract and Contract Documents.

Include in the Stipulated Price, the cost of all work described in this Addendum.

### **ITEM 2: Questions and Answers**

#### **Reference Specifications – Division 01 General Requirements**

**Q4-1. Confirm the specific requirements of the performance bond. The tender documents specify performance bonding requirements but doesn't specify the amount. Should we assume a 50% performance bond?**

Under the general instructions it states: 1.The Bidder shall submit bid security with the bid in the form of a bid bond or a security deposit in an amount that is equal to not less than 10 percent of the bid amount. Applicable Taxes shall not be included when calculating the amount of any bid security that may be required. The maximum amount of bid security required with any bid is \$2,000,000. **Q4-2. Specify the warranty period. Should we assume a standard one-year warranty period?**

Unless stated otherwise in the published solicitation documents (instructions, addendums, specs and drawings) the warranty will follow the contract conditions and clauses listed by reference at Page 6 of 14. **Q4-3. If the answer to question Q4-2 is yes, do we need the following requirements for 6 years beyond substantial completion? The Contractor must be responsible to provide and maintain coverage for Products/Completed Operations hazards on its Commercial General Liability insurance policy, for a period of six (6) years beyond the date of the Certificate of Substantial Performance**

Yes, comply with Supplementary Conditions SC01 at Page 7 of 14.

**Q4-4. Is the Industrial Security Program Organization Number required for this project?**

This is not required as there are no security requirements in this solicitation.

**Q4-5. Is Appendix 2 voluntary and does not have to be completed for this submission.**

Yes, Appendix 2 is voluntary and does not have to be completed for this submission.

**Q4-6. Confirm Certificate of insurance does not have to be included for this submission.**

This certificate is not required at bid closing but will be required before a contract is awarded.

**Q4-7. Is Appendix B voluntary and does not have to be completed for this submission.**

Yes, Appendix-B is voluntary and not required in your bid submission.

**Q4-8. If we exclude all voluntary forms, there are only two pages that need to be submitted, Pages 8 and 9?**

Submit the completed Page 8 of 14 and Page 9 of 14. Submit the signed and completed front page. Do not forget to submit the bid security. See bidders instructions for details; link is above at question Q4-1.

**Q4-9. I see the security requirements Section 01 14 10 – is this mandatory?**

Yes.

**Q4-10. Do you know what the Correctional Centre actual does or what the building is used for (daily office work, place of processing inmates/temporary holding, half-way housing or inmate housing/institution)?**

Daily office work, food programs, other programs, halfway housing – the upstairs has housing rooms.

**Q4-11. Is there a security on site? Is the site fenced and gated? Satellite image doesn't seem to show a fence/gate to the property.**

There is site security and sign in requirements daily; No perimeter fence.

**Q4-12. Are construction workers actually required to sign-in and go through a typical security check similar to that of a police station or more intense process like that of a max. prison?**

Workers are required to sign in and out daily. No tool lists or screening search required.

**Q4-13. A site safety/orientation meeting is listed in the specs as being required for all workers – do you know roughly how long?**

This is approximately up to 30 minutes and delivered by the PSPC Project Officer

**Q4-14. Are workers free to come and go from site as required without signing out or going through security check?**

Workers will be required to sign in and out regardless of how they access the worksite.

**Q4-15. Can a disposal bin be placed immediately beside the building?**

Typically, every effort is made to provide the most convenient location to facilitate the work. The winning contractor to propose a location that will be reviewed by site personnel.
