Answer questions from the industry.

Enquiries - Bid Solicitation - Clause # 2.4

To ensure consistency and quality of information provided to bidders, significant enquiries received and the replies to such enquiries will be provided simultaneously to bidders to which the bid solicitation has been sent, without revealing the sources of the enquiries.

Here are the questions which we have received until now:

Question #1: The question is in regards to the mandatory criteria CO3 and the definition of "similar" projects. A spin-off from another larger organization, only has two projects that meet the definition of similar since operating as the spin-off company name. However, the same employees from the spin-off company were managing projects that met the criteria while they were employees of the larger organization. Since it will be the same staff will be managing this project, can the project from before the company was spun-out from the larger organization be counted towards the three (3) projects required?

Answer #1: Mandatory criterion CO3 allows to evaluate the bidder experience as an organization in the management of "similar" projects to what is specified in the request for proposal. Thus, the experience acquired by resources in one or more projects while they were employed by another larger organization does not allow them to meet the mandatory criterion CO3, even if these resources are part of the company resulting from the split of this other larger organization. Please refer to Article 4.1.1.2 - *Bidder Experience of Part 4 - Evaluation Procedures and Basis of Selection* to know the elements that are acceptable in terms of the bidder experience.
