**Q1. Under Annex C – Insurance Requirements - Commercial General Liability Insurance article 2. i. the following is stated:**

**Broad Form Property Damage including Completed Operations: Expands the Property Damage coverage to include certain losses that would otherwise be excluded by the standard care, custody or control exclusion found in a standard policy.**

**This is an ambiguous condition and should be amended to specifically state what exclusions they want removed or what perils they want included with respect to property under the Custody, Care and Control of the insured.**

**Please clarify what exclusions are required to be removed or what perils are required to be included in the requested insurance coverage.**

R1. Please refer to Amendment 003 article 5. Amend Annex C, Insurance Requirements.

**Q2. For Zone 2 requirement would vendors be allowed to provide hot food onsite using their fully-functional commercial mobile kitchen?**

R2. Yes, vendors would be allowed to serve hot food onsite using their fully functional commercial mobile vehicle.
