9	Does VAC have a secured network (IP address) for these 180 users? If yes, are there other healthcare providers (clinicians) beyond the 180 mentioned in the RFP, that could also have access to this same IP address?	There are two possible IP addresses depending on whether they were going through the Moncton or Charlottetown firewall.
10	Of the 180 clinical users listed under solicitation number 51019-201003/A, how many of them are physicians, nurse practitioners (if any), Physician assistants (if any)?	Of the 180 clinical users listed under solicitation number 51019-201003/A, 51 are physicians. There are no clinical users that are nurse practitioners or physician assistants. Health professionals working at VAC provide professional health advice, consultation, assessments and decisions, as well as advice on legislation and policies, in support of VAC's mission to provide client-centered services and benefits that respond to the needs of clients. Health professionals working at VAC do not provide primary care to clients.
11	If this is IP authenticated, is there a way to limit access to the designated clinicians only or would the IP ranges for VAC be shared with any other organizations who could then potentially also have access to the POC tool?	Our external ranges are used for anyone authenticated to our VAC network.
12	If IP ranges are shared with other organizations, is there a way for you to limit it to the VAC clinicians only?	No.
13	Are there any additional details about the VAC Network setup that you can share with us that may be beneficial to know?	A more specific question is required.
14	Is it OK for the five concurrent trial accounts to be offered by UN (username) and PW (password) for the evaluators utilize?	Yes, the five concurrent trial accounts may be offered by username and password. As per Annex D – Evaluation Criteria, Section 1 – Mandatory Evaluation Criteria, “The Bidder must provide a free trial period for one (1) month access to five (5) concurrent users in order for evaluators to validate the claims of the Bidder.
