This amendment is being raised to extend the solicitation closing date and to distribute questions and answers.

A. Bid Closing Date

The closing date for tender 5P420-20-0154/A is extended from August 25, 2020 to August 26, 2020 at 2:00PM Mountain Daylight Time (MDT).

B. Question and Answer

Q11 Page 5 of 131 of the specs states that the contractor is responsible for sourcing potable water from outside of the National Parks. Accessing local water sources within Parks can be coordinated through the Departmental Rep and the ESO but will require the Contractor to obtain a Restricted Activity Permit (RAP). Can you confirm that the contractor can utilize potable from inside the National Park if a Restricted Activity Permit (RAP) is obtained?

A11 Contractors may be able to access local water sources with a RAP, however there is no guarantee this will be a potable source. If potable water is required the contractor should arrange for it outside of the National Park.

Q12 Are there any utilities anticipated in the work area that will affect construction activities? **A12** There are utilities in the area (fibre, power, sanitary) however none are inside the culvert.

Q13 Section 01 11 00 Summary of work Part 1.2.3.14 states "Riprap is to be sourced from outside the National Parks..." Section 01 14 00 Work Restrictions Part 1.9.4 states "The Contract must determine the quality and quantity of material available and the condition of the PCA pit or quarry made available to the Contractor." Can you please confirm that the contractor can source material from the PCA gravel pit or quarry? If a material source is made available, can you please indicate which PCA gravel pits or quarries will be made available to the Contractor and what source materials are available? **A13** There is no owner supply of riprap for this work. If other granular material are deemed to be required it will be included under prime cost sum, and Section 01 14 00, Part 1.9 may apply.

Q14 Can the Project Superintendent or Deputy Project Superintendent act as the Health & Safety Representative, QC Rep, Enviro Rep, and/or Traffic Control Supervisor?A14 A individual can act in more than one role if they are competent, qualified and have sufficient time to complete all the work required by each role as determined by the departmental representative.

Q15 Is a full time QEP required for this project? **A15** No

Q16 What distance out from the inlet and outlet do you expect to place rip rap? **A16** Rip rap is to be placed as directed by the Departmental Representative, currently estimated as approximately 15m upstream of the inlet and 10m downstream of the outlet.

ALL OTHER TERMS & CONDITIONS REMAIN UNCHANGED
