6	20200150	Regarding mandatory criteria M3 and M4, it is an industry standard that all documents must be kept in strict confidentiality, and nearly all clients rightly insist that provisions to that effect be included in any agreement with a translation supplier, especially in the business areas that are contemplated by the RFP. Indeed, had the work been done for OSFI under this contract, a supplier would be barred from furnishing any samples under subsection 6.18(a) of the Resulting Contract Clauses, which are typical of any contract for professional translation services. Therefore, we request that criteria M3 and M4 be replaced by translation tests or any other means chosen by OSFI that would not ask suppliers to breach their duty of confidentiality towards their clients, and would not in effect favour companies that take liberties with their client’s information to the detriment of those who faithfully abide by their contractual obligations and ethical duties.
