This amendment is raised to answer the following questions from industry:

Q1: In the SOW, section A4.1 Activity 1 Initial Submittals, sub-section A4.1.1 General, lists a number of things that need to be submitted. Point #3 for the Schedule reads as follows: "3. *Schedule (ref. Section A6.2)*". However, section A6.2 is photographs of the frame crane. Is this an error?

A1: Yes, it is a cross-referencing error. The cross-reference should have been to A5.2, which describes the requirements for the schedule which the Contractor needs to submit for Activity 1.

Q2: In the SOW, section A2.4 Lifting Equipment, sub-section A2.4.1 Summary, the last sentence in the first paragraph says: "*The equipment is described in detail in Section A3.4.*" There is no A3.4 in the SOW. Is this an error?

A2: Yes, this is another cross-reference error. The detailed description of the cranes is now right in section A2.4, starting immediately with the frame cranes in A2.4.2 and continuing.

Q3: Will there be a scheduled site visit for Bidders to view the eleven cranes prior to bid submission?

A3: No, due to the COVID 19 Pandemic there will not be a site visit. Please refer to Annex "A" - Statement of Work for picture of the Cranes.
