INVITATION TO TENDER

AMENDMENT #1

THE PURPOSE OF THIS AMENDMENT IS TO GIVE EFFECT TO THE FOLLOWING CHANGE;

- 1. The closing date has changed to Tuesday, September 08, 2020 at 2:00pm EDT;
- 2. Section "SI06 OPENING OF BIDS / EVALUATION" is deleted and replaced by:

SI06 **OPENING OF BIDS / EVALUATION**

- 1. There will be no public opening at bid deposit time.
- 2. Submission 1 - Qualifications - will be opened privately. This submission will be opened first to evaluate the submittal requirements. Requirements will be evaluated on a mandatory and points rated basis. Failure to meet any or all of the mandatory requirement(s) will render the bid non-compliant and no other consideration will be given to the bid. Submission 2 will be returned to the bidder.
- 3. Submission 2 - Price: Only those submissions from Bidder's that meet the mandatory requirements of the Qualifications shall be opened. Submission 2 submittals will be evaluated against the mandatory requirements, failure to comply with any or all of the mandatory requirement(s) will render the bid non-compliant and no other consideration will be given to the bid.
- The responsive bid with the highest combined rating of technical merit and price will be recommended 4. for award of a contract.
- 5. Bid results may be obtained from the Contracting Authority named on the cover page of the Invitation to tender following completed evaluation.
 - 3. Section "SI08 INSUFFICIENT FUNDING" is deleted and replaced by:

SI08 INSUFFICIENT FUNDING

- 1) In the event that the responsive bid with the highest combined rating of technical merit and price exceeds the amount of funding Canada has allocated for the construction phase of the work
 - by 15% or less, Canada, at its sole discretion, shall either (a)
 - (i) Cancel the solicitation: or
 - (ii) Obtain additional funding and, subject to the provisions of GI11 of the General Instructions to Bidders, award the Contract to the Bidder submitting the responsive bid; or
 - (iii) Revise the scope of the work accordingly and negotiate, with the Bidder submitting the responsive bid, a corresponding reduction in its bid price.
 - (b) by more than 15%, Canada, at its sole discretion, shall either
 - (i) Cancel the solicitation; or
 - (ii) Obtain additional funding and, subject to the provisions of GI11 of the General Instructions to Bidders, award the Contract to the Bidder submitting the responsive bid; or
 - (iii) Revise the scope of the work accordingly and invite those who submitted compliant bids at the original solicitation to re-bid the work.
- If negotiations or a re-bid are undertaken as is contemplated in subparagraphs 1)(a)(iii) or 1)(b)(iii) above, Bidders

shall retain the same subcontractors and suppliers as they carried in their original bids.

3) If Canada elects to negotiate a reduction in the bid price as is contemplated in subparagraph 1)(a)(iii) herein and the negotiations fail to reach an agreement, Canada shall then exercise either of the options referred to subparagraphs 1)(a)(i) or 1)(a)(ii).

4. Section "QUALIFICATIONS 4 - PRICE OF SERVICES" is deleted and replaced by:

QUALIFICATIONS 4 - PRICE OF SERVICES

All price proposal submissions corresponding to responsive proposals which have achieved the pass mark of sixty (60) points are opened upon completion of the technical evaluation.

To establish the pricing score, each responsive bid will be prorated against the lowest evaluated price and the ratio of 15 %.

The table below illustrates **an example** where all three bids are responsive and the selection of the contractor is determined by an **85/15 ratio** of technical merit and price, respectively. The total available points equal 100 and the lowest evaluated price is \$45,000 (45).
