Question #1:

I had asked you if the client would be purchasing the cemetery plots themselves when required for full body burial or cremated remains burial, as well as the opening and closing fees. This would be difficult to average out as each cemetery have different fees and varying costs. If required at the time of need I would be willing to help arrange the cemetery for the client. This was not mentioned directly in the tender. The cemetery will charge a fee for the following: Grave (Burial for casket or urn) Open and close the grave (dig and refill) there are costs associated with both of the above items. Each cemetery have varying costs.

Please see the Basis of Payment (BOP). The BOP has been reworded to include the plots and the opening/closing fees in the ground burial and cremation burial service fees. As each cemetery may have different fees, the Basis of Payment has been revised so that the charge for these services is the cemetery charge, plus the service fee for the Offeror. The offeror will determine their service fee.

Question #2:

The question was that since the lowering device is part of any burial service and is provided by the cemetery, does this line need to be included in the BOP? The offeror has no way to price this item. The offeror also noted that there may be confusion regarding the definition of Burial Box. The offeror noted that a burial box is a cement box in the ground and that we were likely referring to a shipping crate which is usually charged at cost. Could we clarify what we are looking for? There is no way you could ship a burial box, the offeror said.

Answer to Question #2:

The additional option of the lower device will be removed from the Basis of Payment, as this will be included in the ground burial service fee. The additional option of the burial box will be removed from the Basis of Payment, as this is will be included in the ground burial service fee.

ANNEX "A" Statement of Requirement CARE OF REMAINS AND FUNERAL SERVICES

1.0 Scope

1.1 Objective:

Provide all labour, materials, equipment and supervision required for indigent funeral services, including burials or cremations and grave markers "as and when requested", for the Correctional Services of Canada (CSC) in the Pacific Region in accordance with applicable legislation and bylaws.

Certain circumstances may require CSC be responsible for a portion of the service or material, and the next of kin responsible for the remainder.

Cremation and Burial Services must be offered in a variety of religious/spiritual backgrounds.

1.2 Background:

As CSC's mandate and mission is to care for inmates, when an inmate passes away the CSC has responsibilities with regards to the body of the deceased. Where the body of a deceased inmate is claimed by the inmate's emergency contact or next of kin, the CSC must arrange for the body to be transported to a funeral home in the person's or next of kin's hometown. In some instances, CSC may assume responsibility for all or part of the costs of the funeral in the hometown of the inmate or of the person who claims the body.

Where the body of a deceased inmate is not claimed, the CSC must arrange for the body to be buried, cremated or otherwise dealt with.

As the previous Standing Offer (SO) has expired, CSC is looking to award a new Standing Offer for funeral services.

In the previous RFSO, only one SO was awarded for all of British Columbia, but for this RFSO two SOs will be awarded. One for each of the geographical areas: Lower Mainland and Vancouver Island.

2.0 Requirements

2.1 Scope of Work:

Services required for cremation or burial, including but not limited to administrative services, registration of death, body removal, and required merchandise.

2.2 Tasks:

1. The contractor must provide the following services, as requested:

a) Cremation, including:

- Internment at municipal cemetery or Indigenous Reserve closest to the releasing institution (District of Kent, Chilliwack, Abbotsford, Mission, or Metchosin), including creation and placement of a grave marker with the deceased person's name, date of birth, and date of death, in accordance with applicable cemetery bylaws using the most economical option commonly available; or
- Transportation of ashes to a funeral home as identified by the site authority; or
- Release of ashes to family member identified by the site authority; or
- Disposal of ashes in accordance with provincial legislation/requirements;
- Cremation service includes, but is not limited to:
 - I. the plot, including opening and closing costs;
 - II. the urn;
 - III. administration, including registration of death;
 - IV. body removal;
 - V. required merchandise.

b) Burial, including:

- Internment at municipal cemetery or Indigenous Reserve closest to the releasing institution (District of Kent, Chilliwack, Abbotsford, Mission, or Metchosin), including creation and placement of a grave marker with the deceased person's name, date of birth, and date of death, in accordance with applicable cemetery bylaws using the most economical option commonly available; or
- Transportation of body to a funeral home as identified by site authority, which may include transportation by air to another province;
- Burial service includes, but is not limited to:
 - I. the plot, including opening and closing costs;
 - II. the casket;
 - III. administration, including registration of death;
 - IV. body removal;
 - V. required merchandise.

2. The contractor must provide the Death Certificate to the site authority.

3. The contractor must provide the following Additional Items, if and when requested:

- a) Embalming services (mandatory, if viewing is to take place);
- b) Venue for service, including: music, hearse, and staff required;
- c) Cremation and certificate, including the use of a disposable urn;
- d) Ceremonial urn, using the most economical option commonly available;
- e) Plastic body bag;
- f) Creating and placement of a grave marker with the deceased person's name, date of birth, and date of death, in accordance with applicable cemetery bylaws and using the most economical option commonly available, at the municipal cemetery closest to the releasing institution (District of Kent, Chilliwack, Abbotsford, Mission, or Metchosin);
- g) Transportation of body (by ground or air from funeral home to destination as determined by CSC, including shipping box);
- h) Transportation of cremated remains (by ground or air from funeral home to destination as determined by CSC, including urn).

Please note: the above noted additional items may be purchased by CSC when CSC is only responsible for part of the costs of the burial or cremation.

4. The contractor must ensure that the venue for service is accessible.

2.3 Deliverables:

The contractor must deliver the services identified in each call-up. The delivery address will be identified in the call-up but is among those listed in Annex "C".

2.4 Constraints:

- The contractor must follow all local burial rules.
- The contractor needs to provide all documents in English.
- The contractor must provide for their own travel and board.

2.5 Support provided by Canada:

The site authority will provide inmate information required to complete the death certificate including full name, sex, date of death, age, and place of birth. The site authority will normally provide the location of

2.6 Timeframe and Delivery Dates:

The site authority will advise the funeral home when the remains are to be released by the Coroner. Services must be provided within five (5) days of notification of release.

2.7 Contractor Qualifications:

The contractor must have at least five years of experience in providing the services identified in the tasks section of this annex.
