### **Description of the Requirement:**

Health Canada's Controlled Substances Directorate (CSD) is seeking the services of a Contractor to conduct a preliminary assessment of up to ten lower-barrier safer supply pilot projects (SSPP) funded through Health Canada's Substance Use and Addictions Program (SUAP). This will include the start-up phase of four multi-year pilot projects, and the duration of six projects receiving short term funding until March 31, 2021.

The objective of this requirement is to do a preliminary assessment of the SSPPs to provide early observations of effective implementation strategies, lessons learned and barriers/issues faced in navigating the establishment of lower-barrier SSPPs in the current health system.

Findings from the preliminary assessment will help inform best or promising practices in SSPP design and implementation.

The Preliminary Assessment will focus on the start-up phase of the SSPPs with the objective of providing early observations on participant and staff experiences, effective implementation strategies, lessons learned and barriers/issues faced in navigating the establishment of lower-barrier SSPPs in the current health system.
