### **QUESTION AND ANSWER**

Q.24

Re: R2 and R3

Within Amendment 005, R2 and R3 included the addition of "o Name of the Contractor (for the contract awarded to the Bidder)". Can the Crown please clarify what is meant by Name of the Contractor? There is already a requirement for the name of the resource and the client reference.

A.24

Under R2 and R3, it is stated in Item 2) that "the services demonstrated in 1) for each named Resource(s) should be delivered for a minimum duration of 6 consecutive months under a contract awarded to the Bidder within the last 10 years prior to the solicitation issue date." The Bidder should use its contract(s) and, if required, contract(s) of other contractors to demonstrate the minimum 5 years' experience of the named Resource. By providing "Name of the Contractor (for the contract awarded to the Bidder)", it identifies which contract(s) was/were awarded to the Bidder and allows the evaluators to evaluate the proposal accordingly.
