This Solicitation Amendment 003 is raised to incorporate response to questions received.

Q1.) Please could you inform me as to whether or not the Chromium that is *in situ* at the Snowbirds clean-up site is (or is definitely known not to be) in the plus-six oxidation state, Chromium(VI) (speciated as Chromate/Dichromate), having perhaps originated either as a component of a military-use battery system (water-soluble Chromium(VI)), or perhaps as a surface coating (water-insoluble Chromium(VI)).

A1.) Chromium was selected in the Golder Stage 2 PSI as a potential contaminant of concern related to the aircraft paint and batteries. It is not known with certainty if the chromium is associated with aircraft paint, batteries or both. Chromium was not speciated as part of the work completed.

All other terms and conditions remain unchanged.
