#### 1. Questions and Answers:

**Q1:** P. 32 Can you be more specific about the term Creation of Inventory (what does this term involve)?

**A1:** Creation of Inventory of qualified and interested Black people and other racialized groups, Indigenous people, as well as persons with disabilities entails establishing and maintaining a list of potential candidates for the Privy Council Office to consider for appointment to various deputy minister roles positions as well as for the Office of the Chief Human Resources and other departments and agencies to consider for assistant deputy minister positions.

**Q2:** Is this an AS AND WHEN REQUIRED BASIS or is this a full time opportunity? **\*A2:** As the objective is to maintain inventory on an ongoing basis, this opportunity will require ongoing work by the firm to ensure the inventory is refreshed every 2 months.

Q3: Is it contemplated that more than one firm could be awarded a contract?

A3: The intent is to award a contract to only one firm.

**Q4:** Order in Council positions all demand a high degree of capability to handle complexity and those at the ADM level somewhat less but still above most roles in the private sector. Is it a requirement that all individuals be profiled to establish their capability to handle these roles? To the best of my knowledge there is no such formal basic requirement for internal people but continued exposure can provide evidence of whether or not "they can figure it out." This is assurance not available to new entrants at senior levels, hence my question.

**A4:** The statement of work sets out that qualified firms will be expected to assess candidates against selection criteria and develop assessment tools/methodology, which should include but not be limited to, interviews, reference checks and psychometric assessments, to be used in the potential candidate search process.

**Q5:** In order to submit a quality bid would the client be amenable to extending the deadline to September 15th?

**A5:** The Privy Council Office agrees to extend the deadline to September 15, 2020.

**Q6:** Give the timeframe, would PCO consider extending the solicitation deadline by a week?

**A6:** The Privy Council Office agrees to extend the deadline to September 15, 2020.
