(1) Reference: Page 10, SC06 FIRST NATIONS LABOUR ENGAGEMENT

DELETE :The contractor must ensure the labour force working on-site in Richibucto is represented by a minimum 33% Aboriginal people. The contractor must provide as a pre-award documentation requirement, a record of engagement (who and when they met with Aboriginal labour forces) to attain Aboriginal workers. The contractor will also be required to maintain a record of the number and role of Aboriginal workers on the project that the Departmental Representative will receive with requests for progress payments; and
INSERT The contractor must ensure the labour force working on-site in **Burnt Church** is represented by a minimum 33% Aboriginal people. The contractor must provide as a pre-award documentation requirement, a record of engagement (who and when they met with Aboriginal labour forces) to attain Aboriginal workers. The contractor will also be required to maintain a record of the number and role of Aboriginal workers on the project that the Departmental Representative will receive with requests for progress payments

(2) Clarification

This is a reminder that you will be required to submit an Environment Mitigation Plan specific to this project. (see section 01 35 44)

This plan shall include the provision for the supply and installation of a silt boom. The silt boom will not be paid separately but should be included as part of your "site work" price.

If your bid has already been forwarded and you wish to revise same, this revision should be sent either in a sealed envelope and mailed to the above address or by facsimile (506) 851-6759 and reach the undersigned before the appropriate closing date.
