- Q.1** Items 12, 13, 14. Indicate in the description “no backrest bolster” however the GoCUID#’s reflect “with backrest bolster”. Can you please double check these as I am in a position to bid if they are in fact without backrest bolster.
- Q2.** Item #17 GoCUID # 6SUCSQXXLUX8XXXLXXX refers to an upholstered stool with casters square with no backrest. The description on the bid says firm seat – seat and backrest are different colours. This is the same description used for the benching items in lines 15 & 16. Please clarify what is needed for item #17

ANNEX A-2

- Q3.** Item #23 GoCUID 6SBBTWXXLUW3G19LMYN refers to double armless bench with legs “With Backrest Bolster” privacy screen and no arms. The description on the items say **No backrest bolster** which would refer to GOCUID # 6SBATWXXLUW3G19LLYN
- Q4.** Item #24 GoCUID 6SBBTHXXLUW5G19LMYN refers to triple armless bench with legs “with backrest bolster privacy screen and no arms. The description on the item says **No backrest bolter** which would be GoCUID # 6SBATHXXLUW5G19LLYN

- Q.5** Item # 2 GoCuid # indicates **Without backrest bolster**
Item #3 & #4 – GoCuid suggests **With backrest bolster**. Please confirm if these items are in fact to have a backrest bolster as they would appear to be required to match item #2 and there is confusion with and without back bolster codes in other places on this tender.
