Amendment 001

This administrative amendment to the Solicitation W8486-207123/A is issued to answer questions regarding the solicitation, and make changes to terms within solicitation document.

Asides from the amendments below; all terms and conditions of the Solicitation remain the same.

Questions

1. Are technical data packages, patterns, and sealed samples available?

Patterns and sealed samples are available upon request to the Contracting Authority by e-mail. Additionally, samples may be borrowed by the Contractor upon contract award.

2. This procurement is conditionally limited to Canadian content. Does this mean both materials and clothing manufacturing must be Canadian sourced? Or can the material be sourced from the US?

A supplier can use foreign material as long as the value of all non-Canadian content in their bid, does not exceed 20% of the overall value.

3. Who was the previous supplier of these goods? What was the award value and cost per units they provide?

Peerless was the supplier on the last contract. They provided these sweatshirts and sweatpants under contract W8486-116965/001/PR. The value of the contract was \$784,037.

DND is not permitted to provide unit prices as per Canada guidelines.

4. Was there a previous supplier for the static dissipative CADPAT jacket (NSN: 8415-20-005-7561).

Peerless was the supplier on the last contract. They provided the RCAF Static Dissipative Jacket under contract W8486-112718/001/PR.

5. Is there an option to receive CADPAT TW electronical posters in PDF format?

Only countries with NATO status are eligible to receive CADPAT TW electronical posters. They can be requested for from the Contracting Authority by e-mail 6. Is the double-sided fleece in both DSSPM 2-2-80-213 & DSSPM 2-2-80-242 the same mass weight 275g/m² and double sided pile? Is using a micro polar-fleece acceptable?

Spec 213 fleece is a double sided "veloured" fleece with maximum mass of 275 g/m², no minimum specified but fabric needs to be of sufficient mass to meet the requirements of the specification in its entirety.

Spec 242 has a different fabric construction: it is a double sided 'veloured' fleece that composed of two single-sided fleece layers laminated to an inner membrane. Because of the 3 layer fabric structure it may be a heavier cloth than the 213 spec fleece. The maximum allowable mass is 410 g/m^2 , again no minimum is specified and the fabric needs to be of sufficient mass to meet the requirements of the specification in its entirety.

Micro-fleece would be acceptable for either as long as the finished fabrics meet all of the requirements of the specifications in their entirety.
