## PART 1 - GENERAL INFORMATION

### 1.1 Requirement

The requirement is detailed under Article 6.2 of the resulting contract clauses

### 1.2 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

### 1.3 epost Connect service

This bid solicitation allows bidders to use the epost Connect service provided by Canada Post Corporation to transmit their bid electronically. Bidders must refer to Part 2 entitled Bidder Instructions, and Part 3 entitled Bid Preparation Instructions, of the bid solicitation, for further information.

## PART 2 - BIDDER INSTRUCTIONS

### 2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The [2003](#) (2020-05-28) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

### 2.2 Submission of Bids

Bids must be submitted only to the Public Works and Government Services Canada (PWGSC) Bid Receiving Unit specified below by the date and time indicated on page 1 of the bid solicitation:

Only bids submitted using epost Connect service will be accepted. The Bidder must send an email requesting to open an epost Connect conversation to the following address:

Note: Bids will not be accepted if emailed directly to this email address. This email address is to be used to open an epost Connect conversation, as detailed in Standard Instructions [2003](#), or to send bids through an epost Connect message if the bidder is using its own licensing agreement for epost Connect.

It is the Bidder's responsibility to ensure the request for opening an epost Connect conversation is sent to the email address above at least six days before the solicitation closing date.

Bids transmitted by facsimile or hardcopy to PWGSC will not be accepted.

## 2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than five (5) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

## 2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

## 2.5 Bid Challenge and Recourse Mechanisms

- (a) Several mechanisms are available to potential suppliers to challenge aspects of the procurement process up to and including contract award.
- (b) Canada encourages suppliers to first bring their concerns to the attention of the Contracting Authority. Canada's [Buy and Sell](#) website, under the heading "[Bid Challenge and Recourse Mechanisms](#)" contains information on potential complaint bodies such as:

## 3.1 Bid Preparation Instructions

The Bidder must submit its bid electronically in accordance with section 08 of the 2003 standard instructions. The epost Connect system has a limit of 1GB per single message posted and a limit of 20GB per conversation.

The bid must be gathered per section and separated as follows:

Bids transmitted by facsimile or hardcopy will not be accepted.

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of hard copy of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to incorporate environmental considerations into the procurement process [Policy on Green Procurement](https://www.tbs-sct.gc.ca/pol/doc-eng.aspx?id=32573) (<https://www.tbs-sct.gc.ca/pol/doc-eng.aspx?id=32573>). To assist Canada in reaching its objectives, bidders should:

## **PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION**

### **4.1 Evaluation Procedures**

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

#### 4.1.1 Technical Evaluation

##### 4.1.1.1 Mandatory Technical Criteria

The bidder must provide documentation demonstrating that their proposed wireless mobile column lifts meet the following minimum specifications:

#### 4.2 Basis of Selection

##### 4.2.1 Basis of Selection - Mandatory Technical Criteria

A bid must comply with the requirements of the bid solicitation and meet all mandatory technical evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.

### PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

## **5.1 Certifications Required with the Bid**

## **ANNEX A REQUIREMENT**

The Department of National Defence (DND), Canadian Forces Base (CFB) Kingston Ontario Logistic Support Squadron has a requirement for the delivery, installation and training of eight (8), wireless mobile column lifts for vehicle maintenance.

The Contractor must provide the wireless mobile column lifts as outlined below

### **1. Specifications**

- a. The system must consist of a minimum of eight (8) interchangeable columns. The columns must work when arranged into different configurations and groupings by the operator without the need to modify the control software.
- b. The columns must operate (if required by the client) in a synchronous manner (as a set).
- c. The system must have a deep cycle battery power system that powers the lift during operation, rechargeable on a 110 volt, 50-60 Hz, 1 phase power supply.
- d. The system must operate without the need to be connected by any form of wire during operation;
- e. Must include a fully Battery Operated System With On-board Charger
- f. Wireless communications between all eight (8) columns
- g. Surge protection to prevent damage the electronic systems
- h. Comply with American National Standard for Automotive Lifts – Safety Requirements for Construction, Testing, and Validation (ANSI/ALI ALCTV), the requirements laid out by Electrical Testing Laboratories (ETL) and/or Underwriters Laboratory (UL) in terms of safety, and the system must be Canadian Standards Association (CSA) approved
- i. System must operate without pulsating, jerking, or instability during the lifting process and the system itself must be electronically controlled.
- j. The system must have attachments that are compatible with wheels of a diameter between 31.5” and 49”.
- k. The system must have a small turning radius in order to manoeuver the equipment in confined spaces.
- l. Lifting Capacity
  - i. Each column must lift a minimum load of 18,000 lbs
- m. Hydraulic pallet jack mechanism
  - i. The lift must have some form of pallet jack transport system which is operated by an individual when required
  - ii. The system must come equipped with a damper system to allow the lift towers to be moved safely across an uneven shop floor when the transport system has been activated.

- iii. The column must be equipped with front mounted roller bearings made of steel or nylon impregnated with oil. The roller must not require lubrication and maintenance.
  - n. Controls
    - i. The columns must be individually controllable and able to be manually disengaged and removed
    - ii. Must come with a controller with a tactile display and screen must be designed specifically for the hostile environment of a shop floor
  - o. Safety Mechanisms
    - i. Each column must have an emergency stop mechanism which must be easily accessible
    - ii. The system must have a method of locking the lift at its current height
    - iii. The system must have a safety alarm that alerts personnel that the system is in operation
  - p. Manuals
    - i. Manuals must be provided in both English and French
    - ii. Manuals must cover operation and maintenance
    - iii. Manuals must be provided in both electronic and hard copy form
  - q. Training
    - i. Training on the usage and maintenance of the equipment must be provided after delivery and installation.
    - ii. Training must be provided in English
