1) Questions & Answers

Question 1: Table A1- Rotary Chairs, Lumbar - Adjustable - In/Out - The "In/Out" Lumbar adjustment is not specified in ergonomic guidelines, such as BIFMA G1 or CGSB 44.232. On the SA specifications in Annex A, "5.5 Lumbar Support Height – must be available as fixed or adjustable" but does not require the lumbar adjustment to be in/out. As this may be a preference for specific people, but not required by all users, can we ask that this specification be considered optional but not mandatory?

Answer 1: No, we want the chairs to be adjustable in as many ways as possible.

Question 2: Table A2 - Side Chairs, Horizontal Nesting has been requested, however we have a chair that meets all the other criteria and allows for Vertical Stacking up to (4) chairs. Since the chairs are light weight of 20lbs, would Vertical Stacking also be acceptable?

Answer 2: No, we want a horizontal nesting.

Question 3: Table A1- Rotary Chairs, will the client accept bids for a Standard Back chair for this requirement?

Answer 3: No, please bid following the specifications.
