SOLICITATION AMENDMENT 001

This amendment is raised to answer questions received from Industry and to update the RFP where applicable.

QUESTIONS & ANSWERS

Q1: Is it possible for Canada to provide solicitation documents in their native format?

A1: Yes. Upon request, Canada may provide specific solicitation documents in their native format to the requesting supplier via e-mail. Should there be any discrepancies between the shared native format documents and the respective versions posted on Buy&Sell, the latter documents will take precedent.

Q2: All of the attachments to Appendix 3 to Annex A – Standard Report Categories and Examples don't seem to be attached. Can Canada provide them?

A2: The referenced documents are included in the RFP package though the titles may appear to be unclear or difficult to identify. The Reporting Templates (Attachments 1 - 6 to Appendix 3 to Annex A) are available in native MS Excel format upon request. See answer #1 above.

Q3: In Appendix 1 to Attachment 3.1 to Part 3 – Mandatory Technical Evaluation Criteria, the required format for MS Project is 2019. However, in Appendix 2 to Attachment 3.1 to Part 3 – Point-Rated Technical Evaluation Criteria, the required format is 2013. Can Canada confirm which version is required?

A3: MS Project 2019 is the required version for both evaluation criteria. Refer to RFP Revision 1 below.

Q4: Will Canada consider allowing for the experiences of a Bidder's subcontractor(s) to be accepted as part of the RFP response, including the bidder's corporate experience? It is common in the industry for bidders to subcontract for certain services required under the SOW, so bidders may not have had direct experience providing specific services themselves.

A4: As per Attachment 3.1 to Part 3 - Technical Bid Requirements and Bidder Instructions, a Customer Reference Contract is defined as a contract that the Bidder held to deliver services to a customer and is used to demonstrate the Bidder's experience. To clarify, these Customer Reference Contract(s) are not limited to contracts where the Bidder performed all required services themselves; the Bidder may have subcontracted the delivery of some or all services, under the cited Customer Reference Contract, to a subcontractor(s) while still remaining responsible for the management of the overall contract.

Further, the subcontractor(s) that were utilized to deliver services under the cited Customer Reference Contract(s) may be different than those proposed in response to M-2.1 Subcontractor Plan to deliver Work for this requirement.

Q5: In order for Canada to benefit from innovative and cost-saving opportunities, it is recommended that Canada ensures that Point-Rated Evaluation Criteria R-3.1 and R-3.2 consider cost-savings to the Crown. Savings should be at the program level.

A5: The recommendation has been reviewed. However, the requirement remains as is.

Q6: Given that the incumbent contractor was eligible to be paid the Performance Incentive Fee (PIF) for the current contract, and given that they have presumably all participants and providers registered, why would they be eligible for a PIF under this contract? The PIF should be a one-time opportunity for any provider and should not be repeated on a procurement by procurement basis as it represents a windfall to an incumbent contractor.

A6: This requirement is separate from any other requirement, including the previous solicitation, and will be treated as such. The requirement remains as is.

Q7: If two companies form a joint venture to submit a bid, do both parties have to meet the Insurance Requirements stipulated in Annex D?

A7: If both parties have completely separate insurance programs from one another upon which each will rely for its insurable interest, the answer is yes, both sets of policies will each need to meet the Insurance Requirements.

There are two other insurance options available to a joint venture as follows:

- a) standalone insurance policies solely for the joint venture, with both parties as Named Insured; or
- b) one party who meets the Insurance Requirement adds the other party as Named Insured to its insurance policies with respect to the ASO contract.

Q8: To account for the complexity of the requirement, the level of effort required to submit a bid, and the restrictions resulting from the COVID-19 pandemic, will Canada provide a one-month extension to the solicitation period.

A8: The RFP issuance date was already delayed several months to alleviate stress on suppliers as they attempt to meet the challenges presented by the ongoing pandemic. Additionally, the current solicitation period is 3 weeks longer than usual to account for the complexity of this requirement. Finally, a near complete draft version of the RFP was shared with registered participants during the industry engagement phase. As such, an extension of the RFP closing date will not be considered at this time.

Q9: SOW Article 4.14.5 - Can the Canada explain why FSC to a Protected B level is a requirement? Our understanding is FSC clearance is intended for classified information (Confidential, Secret, Top Secret). Is a Designated Organization Screening (DOS) and Document Safeguarding Capability (DSC) sufficient for Protected B information? Can you please confirm.

A9: Yes, a Designated Organization Screening (DOS) facility security clearance of the type Document Safeguarding Capability (DSC) to the level of Protected B is acceptable. Refer to RFP Revision 2 below.

accordance with the Government of Canada Directive on Security Management: <https://www.tbs-sct.gc.ca/pol/doc-eng.aspx?id=32611>.

3. At Annex A, SOW, Article 3.15 Security Set-Up

DELETE: During the Start-Up Phase, the Contractor must put in place all Security requirements, including obtaining necessary Security Clearances: 1) Personnel Security Screening Division (PSSD) and 2) Industrial Personnel Security Services Directorate (formerly combined in forming the CISD) of PSPC Certification.

INSERT: During the Start-Up Phase, the Contractor must put in place all Security requirements, including obtaining necessary Personnel and Organization Security Clearances, through PSPC's Contract Security Program (CSP).

- iii. The CSP will identify any deficiencies requiring remedial action and the Contractor must make necessary adjustments until such time as the Contractor has satisfactorily met the requirements for Protected B for all sites.
