R13.1	Section 1.8 is "Terminology Clarification" to define the meaning of various EFCD. Paragraph 4 is an (I) informational item. It is not meant to define a specific configuration. Annex D, Section 3.1, paragraph 21 is poorly worded. It is being changed to "The Livescan, equipped with a foot pedal, must allow the OLU to force the capture of fingerprint images or a photo. (M)" Refer to Annex B to Appendix A, section 2 Detailed Device Hardware Specifications, regarding what is mandatory versus optional.

A modern CPU running at a base 2.6Ghz can also compensate with boost up to 5.0Ghz for heavier	R13.2	A Laptop with a modern CPU running at a base of 2.6Ghz is acceptable as long as it has at least 4-cores and satisfies all other Laptop requirements.
