This solicitation amendment has been raised to respond to the following questions:

Question 1:

For item 1.6 would 0 – 70,000 lbs. be acceptable.

Answer 1:

Yes this range would be acceptable

Question 2:

For item 1.7 would 150% of the scale capacity be acceptable?

Answer 2:

Yes, a minimum of 10,000 lbs over capacity is acceptable, more than 10,000 lbs over capacity is also acceptable.

Question 3:

Could you include a temperature range for item 1.8?

Answer 3:

Temperature range of at least (-20 C to + 50 C).

Question 4:

Item 2.2 if the scale is certified to Mil-Std 810G Explosive Environments, is that acceptable?

Answer 4:

Yes, that would be accepted.

Question 5:

Item 2.4 If the scale's display is an OLED, (organic light-emitting diode) is that acceptable?

Answer 5:

Yes, that would be accepted.

Question 6:

Expected lead time could be 45-60 days near year end. Can the order be place before 1 November 2020 for the equipment to clear customs and arrive in Canada before 31 January 2021?

Answer 6:

Yes

Question 7:

For item 1.1 and 1.2 is this the weighing surface or the overall dimension of the scale?

Answer 7:

This is the overall dimension of the scale.

Question 8:

Please clarify certified in point 2.2

Answer 8:

These scales are used to weigh ammunition and must be certified for use for these purposes. There are more than one certification that would be acceptable. Please note in point 2.2 below "Explosion Proof" has been removed from the requirement.

Question 9:

Is a copy of certification required?

Answer 9:

Yes, a copy of the certification must be included to verify the certification.

Question 10:

Can you specify the models of aircraft these scales will be used for?

Answer 10:

These scales are used to weigh equipment that is loaded on to aircrafts, this can include vehicles, ammunition, trailers, air craft pallets, etc. They are normally used outdoors.

Question 11:

What accessories are required with the aircraft scales?

Answer 11:

Two Ramps per scale is required. Storage container with wheels is also required.

Question 12:

0.5lb increments are not common up to 70,000 lbs. Would 10lb increments be acceptable for the scale?

Answer 12:

Yes, 10lb increments would be acceptable.
