This amendment is raised to:

- A. Answer questions from bidders

A. Questions and Answers

- Q30.** Please confirm that the dredging to be carried out is: either under the proposed cribs, or under the existing breakwater or between the existing breakwater and the new breakwater (including the key for the armour stone) therefore no dredging to be carried out in the channel or basin?
- A30.** The dredging works, including stable excavation slopes due to the sandy granulometry of sediments, are effectively limited to the sectors of the new wharves, the surface of the new navigation basin lying between the breakwater to be demolished and the new breakwater as well as the key for the outer armour stone of the new breakwater.
- Q31.** The ballast stone behind the wooden wall is payable in which item?
- A31.** Include the value of ballast stone intended for backfilling behind the wooden wall in Item n°4 – Cribwork.
- Q32.** Concerning the necessary safety and health measures related to COVID19 , does the contractor have to foresee his costs in his bid or is the bid submitted without COVID and an amendment to the contract will be sent afterwards according to the actual measures required?
- A32.** The contractor must provide for all security measures and all sanitary costs related to COVID.
