The purpose of this revision is to provide answers to supplier's questions relating to this solicitation as detailed in Section A.

SECTION A

Questions and Answers

Question 1

Is the due date for submission of all documents on September 28, 2020?

Answer 1

As per Solicitation amendment no.: 003 posted on September 10, 2020, the closing date for this Request for Supply Arrangement is September 28, 2020 at 2:00 p.m. EDT.

Question 2

Does our Account Manager need to be bilingual in French and English? Our Account Manager and other recruiting officers have university degrees, and as a supplier, we are able to provide correspondence and documentation in both official languages but our Account Manager is not bilingual.

Answer 2

As per article 4.2 - Official language requirement of the Statement of work (SOW): *The Contractor must provide its services (written and oral) in both official languages, as required, throughout the project and ensure that its services are of equal quality in both official languages. It is imperative to address candidates and other members of the public, such as references, in written and oral communications with an active offer to communicate in their preferred language. Outreach, recruitment activities and materials and any additional advertising must be developed and implemented in both official languages.*

As per article 6a) – Contractor qualification of the SOW, the account manager must be able to communicate effectively verbally and in writing in both official languages.

Question 3

As we are an existing supplier with a standing offer from temporary help services to Public Works and Government Services Canada, we obtained security clearance in the past for this application. Do we as a supplier need to re-submit for security clearance for this bid or does the previous clearance expire?

Answer 3

The Contractor must, at all times during the performance of the Supply Arrangement/Contract, hold a valid security clearance detailed in Part 6A – Supply Arrangement of the Request for Supply Arrangement (RFSA). The Supplier must ensure through the Contract Security Program that they and proposed individual(s) hold a valid security clearance at the required level, as indicated in Part 6A, clause 6.2, Security Requirements. Security clearances do expire and each supplier is responsible in ensuring that it is still valid.
