(1) Bidders' Questions and Answers

QUESTION # 14:

In Annex C, Requirement 3.1.4.3 states "a pull force range of 3lb to 3.5lb". Can you confirm if the adjustment range is confined to 3-3.5lb or must the trigger to be set break at 3-3.5lb. The wording needs a little clarification please.

ANSWER # 14:

The trigger adjustment range must include a range of 3 lb to 3.5 lb. This requirement is not meant to confine the adjustment range to 3 lb - 3.5 lb. The adjustment lower limit can be below 3 lb, and the upper limit can be above 3.5 lb.

QUESTION # 15:

We were wondering if it would be possible to reissue Annex A, the price document, in excel format, as it would make it much easier for all parties to complete. The one that was sent out in the Compliance solicitation earlier this year was in that format.
