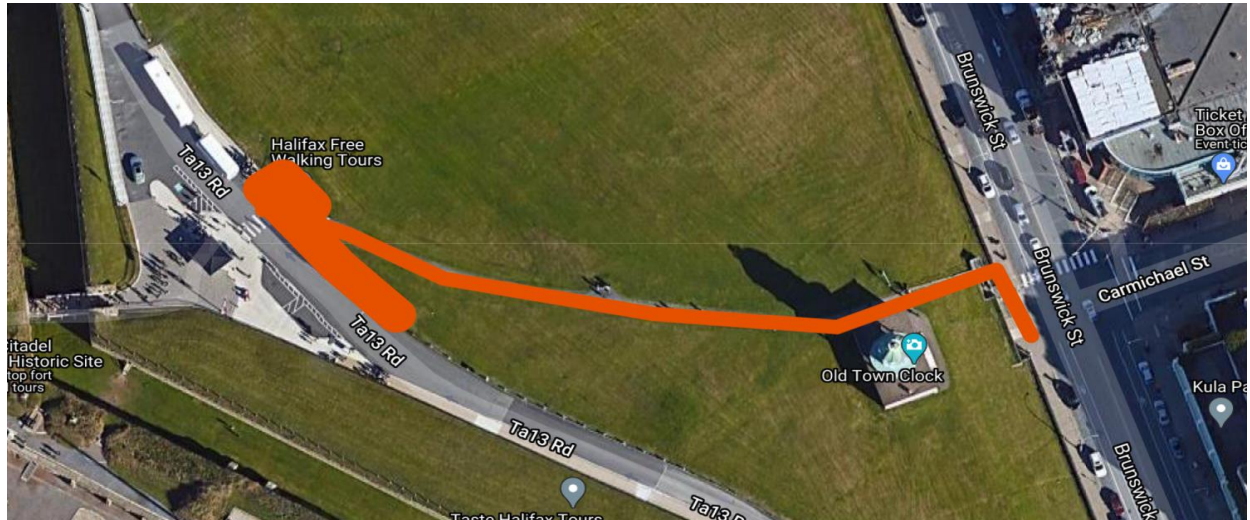

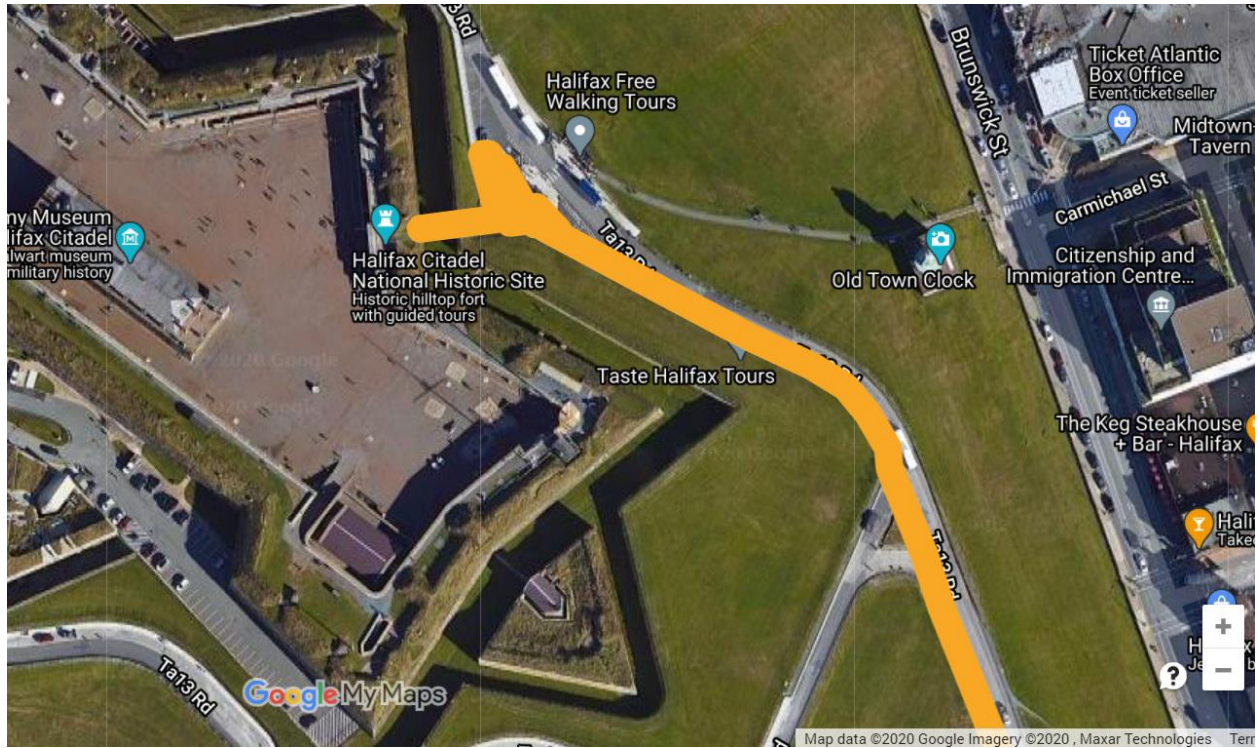

Sidewalk and area in the front Kiosk to be cleared



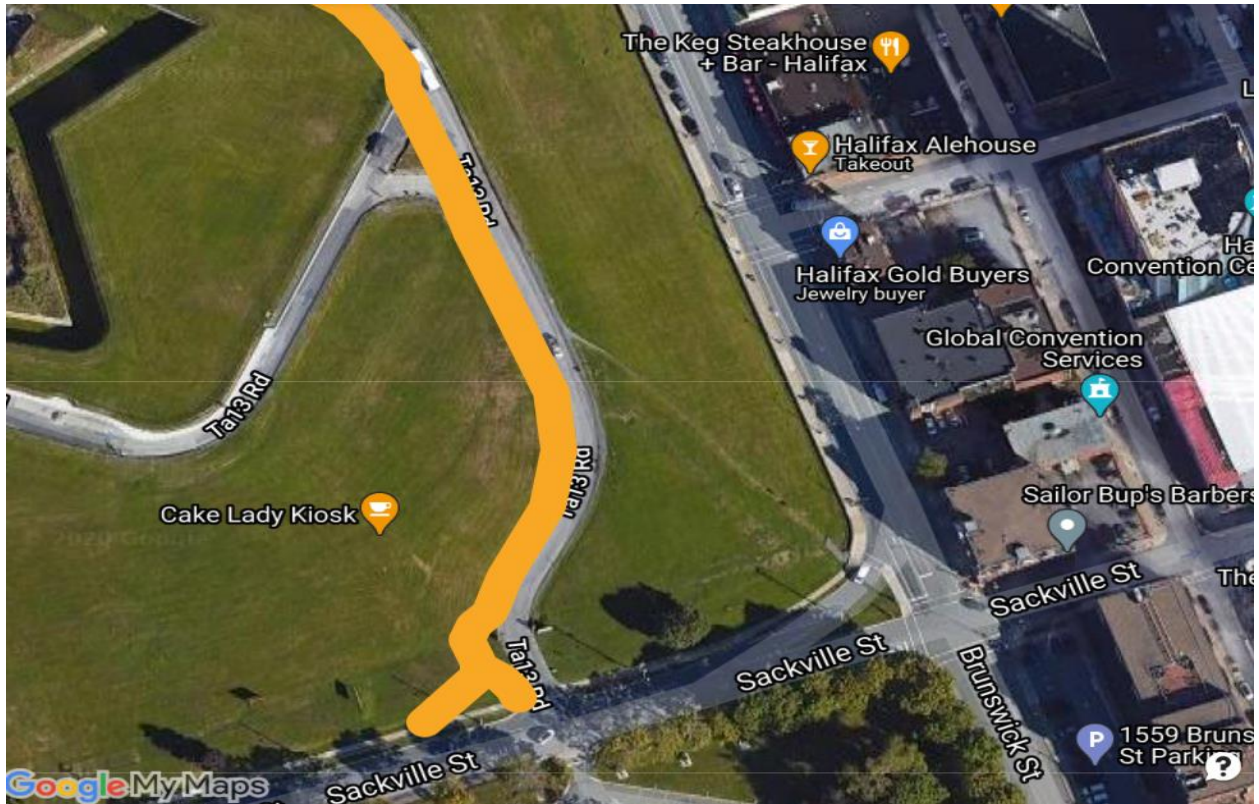

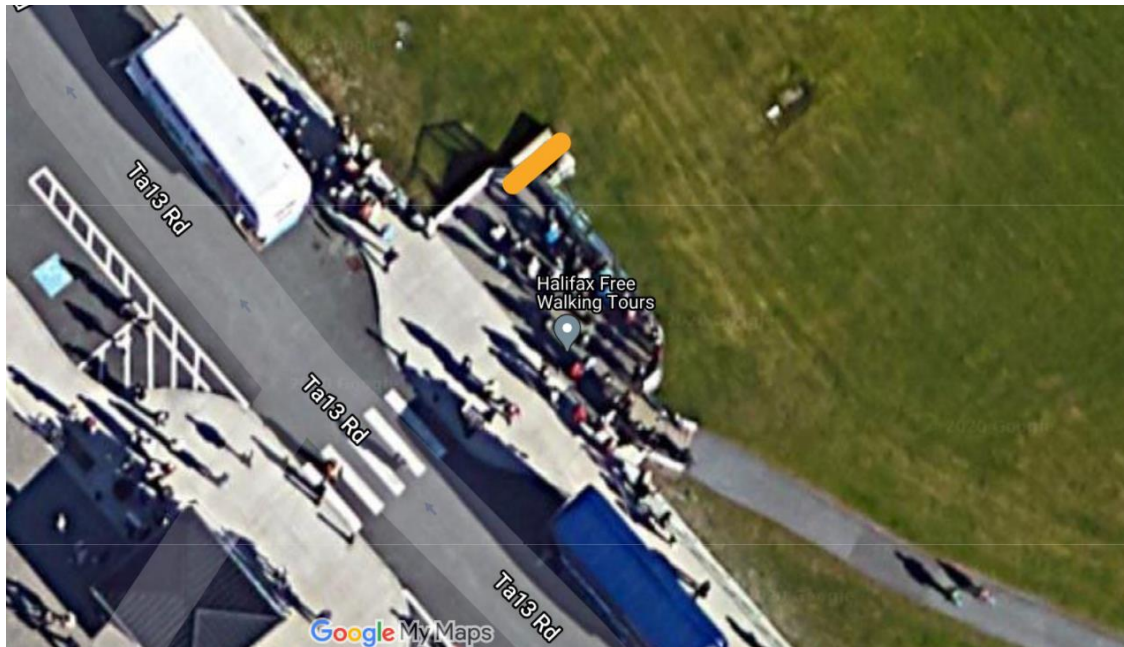
