Question 3

RS 2.2.9 States:

Provide a Senior Planner who has demonstrated experience in providing competent input in the following specialties including Community Development Planning, Urban Renewal, Land Use Planning, Opportunity Assessment, Land Development, as well as public participation meetings and negotiations with municipalities, First Nations, Government Departments and other stakeholders.

There is no mention of a planner anywhere else in the document, including on the tender price form. Is a planner required on the team? Would it be acceptable to use a subconsultant?

Response 3

Yes, a sub-consultant would be acceptable for this. A planner doesn't need to be part of the core team, but we may use the standing offer for civil infrastructure projects that require the involvement of a planner, if the need arises. Pricing for the Senior Planner is not required at this time.

All other terms and conditions remain unchanged.
