(1) Bidder's Question and Answer

QUESTION # 23:

As our submission is required to be sent by e-post Connect we are wondering if you can send us an invitation to join an epost Connect conversation as a participant.

ANSWER # 23:

Bidders must submit their bid via epost Connect in accordance with section 2.2 of the RFP and section 8 of the [2003](#), Standard Instructions - Goods or Services - Competitive Requirements.

In particular, Bidders, who do not use their own licensing agreement for epost Connect provided by Canada Post Corporation, must send as early as possible, and in any case, at least six business days prior to the solicitation closing date and time, (in order to ensure a response), an email that includes the bid solicitation number to the specified PWGSC Bid Receiving Unit (email address: tpsgc.dgareceptiondessoumissions-abbidreceiving.pwgsc@tpsgc-pwgsc.gc.ca) requesting to open an epost Connect conversation. Requests to open an epost Connect conversation received after that time may not be answered. If the Bidder sends an email requesting epost Connect service to the specified Bid Receiving Unit, an officer of the Bid Receiving Unit will then initiate an epost Connect conversation. The epost Connect conversation will create an email notification from Canada Post Corporation prompting the Bidder to access and action the message within the conversation. The Bidder will then be able to transmit its bid afterward at any time prior to the solicitation closing date and time.
