This amendment 001 is raised to answer the following questions from industry:

Question 1:

Annex A - Please clarify the quantity of degaussers. We believe there is one (1) required for each location for a total of two (2).

Response 1:

Total of two degaussers, 1 required in each location

Question 2:

Annex A - Please clarify the number of optical media disintegrators. We believe there is one (1) required for each location for a total of two (2).

Response 2:

Total of two optical media disintegrators, 1 required in each location

Question 3:

Annex C - Compliance Matrix - In the compliance matrix under 3.0 the request includes destruction of Magnetic IT Media to 10mm squared. Under ITSP 40.006 V2 for High Sensitivity Items (Secret/TS/Pro C) the requirement is to destroy to less than 40mm squared after sanitization. In this case you we believe you would be sanitizing with the degaussers prior destruction. This would allow you to shred to 40mm squared, significantly improving throughput. Please review and clarify.

Response 3:

Correct, we would firstly degauss followed with destruction of magnetic IT media by sending them to be smelters at an approved site.

Question 4:

Annex C - Compliance Matrix - The request is for an optical media disintegrator however the compliance matrix includes destruction of Magnetic hard drives. Optical media disintegrators are not designed to destroy magnetic media hard drives. Are you looking for a machine that will also destroy magnetic media such as hard drives? -

Response 4:

The RCMP is looking to procure both degausser and optical media disintegrator to be able to handle the destruction of magnetic drives as well as solid state. We require a single device that will destroy both magnetic, optical, Solid State, cellphones (with battery), Tablets, and USB Devices to the requires specs specified in Annex "A" Requirement and Annex "C" Compliance Matrix .

Question 5:

Annex C - Compliance Matrix - The request is for an optical media disintegrator however the compliance matrix includes destruction of solid state drives. Optical media disintegrators are not designed to destroy solid state hard drives. Are you looking for a machine that will also destroy solid state drives to 2mm x 2mm?

Response 5:

We require a device that will shred Solid state drives, USB Devices, Tablets and Cellphones to the required size. If this devices is on the RCMP SEG list then is good for our use.

Question 6:

Annex C - Compliance Matrix - The request is for an optical media disintegrator however the compliance matrix includes destruction of cell phones. Optical media disintegrators are not designed to destroy entire cell phones. Are you looking for a machine that will also destroy cell phones to 2mm x 2mm?

Response 6:

Cell phones are not currently the RCMP's responsibility however they could be in the future. Cellphones are now DND responsibility to destroy if they have been in a Security breach or cannot be wiped. The device need to be able to destroy these devices, with the batteries, as they batteries cannot be removed from most cellphone/tablets. The term Optical Media Disintegrator may be misleading. What is required is a device that will shred Optical Media, Solid State Drives, USB Devices, Cellphones, and Tablets, to the approved size.
