This Amendment 007 is raised to answer questions received in response to the Request for Standing Offer (RFSO).

Question 4

On page 67, item 3.2.3 Past Experience:

1. Asks for demonstration that over at least the past 2 years; and
2. What the Offeror should provide: a) projects completed over the last 2 years.

Please clarify if we can use project experience completed over a longer period, i.e. 5 – 10 years?

Response 4

The projects should have been completed within the last 2 years. The projects could have been initiated at an earlier date.

Question 5

RS 2.2 Engineering & Land Development Services – Point #11: *Provide Prime Consultant services. Assemble and oversee a project team that provides expertise in other disciplines (such as water and wastewater treatment, architectural, electrical, mechanical, structural, geotechnical, land survey, and environmental) for multi-disciplinary projects where it is determined by PSPC that having the civil engineering consultant as Prime Consultant is appropriate.*

Are there points awarded for the demonstration of providing the “other expert disciplines” indicated in RS 2.2 (architectural, electrical, mechanical, geotechnical, land survey and environmental) by the Offeror? I.e. Are you requesting that we provide evidence that we can provide these services or are these considered “non-core” to the Standing Offer and therefore not part of the evaluation?

Response 5

The other disciplines are “non-core” to the standing offer and these services could come from sub-consultants. They can also come from in-house resources if the Offeror has such resources on staff. In-house abilities regarding “non-core” services will not be part of the evaluation. However, it would be good if one of the example projects could demonstrate coordination of other disciplines (whether they are sub-consultants or in-house) under the lead of the civil engineering consultant.

Question 6

Would inclusion of the services listed in section RS 2.2 (architectural, electrical, mechanical, structural, geotechnical, land survey, and environmental) as part of the response to Hypothetical Project #1 be considered “conforming” or “non conforming” with respect to the stated evaluation criteria for the hypothetical indicating that the response will be evaluated regarding conformance to the RS (Required Services)?”

Response 6

The inclusion of services from other disciplines would be considered “conforming” and would be evaluated on the basis of whether these services are relevant to scope of work described in the hypothetical problem.

Question 7

RS 2.2 Engineering & Land Development Services – Point #11: *Provide Prime Consultant services. Assemble and oversee a project team that provides expertise in other disciplines (such as water and wastewater treatment, architectural, electrical, mechanical, structural, geotechnical, land survey, and environmental) for multi-disciplinary projects where it is determined by PSPC that having the civil engineering consultant as Prime Consultant is appropriate.*

Are the roles associated with these services independent of the rate sheet and to be negotiated post award? For example, would a Junior Electrical Engineer be tied to the Junior Engineer rate on the rate sheet or are they independent?

Response 7

They are independent. Electrical engineering services (and any other discipline outside Civil/Municipal Engineering) could be carried out by a sub-consultant and services could be charged out as a call-up disbursement at market rates.

All other terms and conditions remain unchanged.
