SOLICITATION AMENDMENT 006

The purpose of this amendment is to answer bidder questions.

Questions and Answers:

Question 36:

Our card manufacturing and personalization facility in Canada has earned and maintains ISO 9001:2015 certification as follows: Plastic card manufacturer including smart cards and RFID cards with complete personalization, packaging and fulfillment services, serving the banking, insurance, retail, petroleum, telecommunication, healthcare, governmental and educational sectors. Our company manufactures more than 20 million government issued driver licences and identity cards annually. In addition, we personalise and mail over 15 million bank cards and identification cards for financial institutions and government agencies. With this as background, please consider ISO 9001:2015 as an acceptable certification for this contract.

Answer 36: ISO 27001 is a different certification than ISO 9001:2015 and cannot be considered as equivalent. For the purpose of this contract, Canada requires that the selected vendor holds a ISO 27001 or the ISO 14298 Intergraf – Central Bank Level (as mentioned in Q#7 of amendment 002 published on August 27, 2020).
