REQUEST FOR QUOTATION AMENDMENT NO. 001

Request for Quotation Amendment no. 001 is raised for the following reason:

- To correct clauses and conditions;
- To modify the List of deliverables and Prices

Modification 1

On page 5 of the Solicitation, in "2.1 (d) (ii)

Delete:

No Substitute Products: Bidders must provide products that are of the same description, brand name, model and/or part number as detailed in the item description of the bid solicitation. Bidders are advised that substitute products will not be considered.

Replace with:

Certain products required under this solicitation have been specified by brand name, model or part number in order to ensure compatibility, interoperability and interchangeability with existing equipment owned by Canada. Therefore, the section of SSC's Standard Instructions entitled "Evaluation Procedures for Proposed Equivalent Products" applies with respect to the evaluation of any equivalent products.

Modification 2

On page 9 of the Solicitation, 3.4 Technical Bid:

Insert:

Substantiation of Technical Compliance (Annex B - Substantiation of Technical e) Compliance): The technical offer must substantiate the compliance of the proposed products of Annex A - List of Deliverables (LOD) identified in the Substantiation of Technical Compliance Form, which is the requested format for providing the substantiation. The Substantiation of Technical Compliance Form is not required to address any parts of this solicitation not referenced in the form. The substantiation must not simply be a repetition of the requirement(s), but must explain and demonstrate how the offer does or will meet the requirements and carry out the required Work. Simply stating that the offer or its proposed solution or product complies is not sufficient. Where Canada determines that the substantiation is not complete, the offer will be declared non-compliant and disgualified. The substantiation may refer to additional documentation submitted with the offer – this information can be referenced in the "Reference" column of the Substantiation of Technical Compliance Form, where Offerors are requested to indicate where in the offer the reference material can be found, including the title of the document, and the page and paragraph numbers; where the reference is not sufficiently precise. Canada may request that the Offeror direct Canada to the appropriate location in the documentation.

Annex B is only mandatory if the vendor proposes a different product than what is referenced in Annex A – List of deliverables and prices

Modification 3

Regarding Excel attachment:

DELETE in its entirety and REPLACE with:

"2BH070299 ITPRO# 52050 RFQ ANNEX A - LOD - EN - V2"

Modification 4

Include Annex B:

"2BH070299 ITPRO# 52050 - Annex B - Substantiation of Technical Compliance"

This form is required for vendors submitting a bid for the product not on Annex A.
