**Question 7:**

There's some pods where there's two ceiling poles, is it one for the ceiling feed and one empty for their cables or both of them are for ceiling feed?

**Answer 7:**

The number of pac poles is usually determined by the amount of stations in the section because we pull our electrical through one and our data cables through the other ceiling pole for the stations.
