This Solicitation amendment no. 1 is raised to reply to bidders questions.

Question 1

Can you please clarify the security requirements for this solicitation? Specifically, which resources will require Secret clearance, and which will require Reliability clearance?

Answer 1

Before award of a contract, the Bidder's proposed individuals must have a Secret Clearance.

Question 2

Regarding corporate mandatory/point-rated requirements M.1 & R.1: These requirements are asking for Bidders to demonstrate the provision of resources in at least three of the four specific resource categories listed. Clients often use different resource category titles interchangeably for procuring resources to perform the same services (i.e. Project Coordinator, or Project Administrator, or Project Office Specialist). Because of this, would the Crown please accept a similar resource category as long as the Bidder demonstrates that the work delivered under each resource category included at least 60% of the associated tasks listed in the Statement of Work at Annex A of this bid solicitation for that category of personnel?

Answer 2

Providing the essence of the role is the same and the proposed resources meets the criteria outlined in the RFP then Canada will accept resources with different titles.

Question 3

Would be able to provide us with a word version of the RFP and attachments.

Question 4

We respectfully request that the closing date be extended by 2 weeks to November 6th.
