Amendment 001 has been raised to publish clarification and all answers to questions received to-date.

1. The Solicitation is changed as follows:

1.1 At page 28, under Annex F - Environmental Consideration and Commitment Information

Delete: All packaging material related to this procurement must be reusable, recyclable or compostable." to "All packaging material related to this procurement should be reusable, recyclable or compostable, where feasible.

Insert: All packaging material related to this procurement should be reusable, recyclable or compostable, where feasible.

2. QUESTIONS AND ANSWERS:

Question 1

What is the Canadian Content Policy?

Answer 1

The Canadian Content Policy is a Policy that limits, in specific circumstances, competition for government procurement opportunities to suppliers of Canadian goods and services.

Question 2

Does the Canadian Content Policy apply to this procurement?

Answer 2

Yes. Per Section 5.2.3.4, this procurement is solely limited to Canadian goods. This means that only suppliers of Canadian goods are eligible to be awarded a contract.

Question 3

Are foreign suppliers eligible to bid on this procurement?

Answer 3

It is not required that suppliers be located in Canada or be of Canadian origin/nationality in order to bid. Foreign suppliers are eligible to bid so long as the goods they provide are Canadian goods.

Question 4

Are Canadian suppliers who supply foreign goods eligible to bid on this procurement?

Answer 4

No. Only suppliers of Canadian goods are eligible to be awarded a contract.

Question 5

How do I determine whether or not my goods are Canadian goods?

Answer 5

- A good wholly manufactured or originating in Canada is considered a Canadian good.
- A product containing imported components may also be considered Canadian when it has undergone sufficient change in Canada, in a manner that satisfies the definition specified under the North American Free Trade Agreement (NAFTA) Rules of Origin (as found in [Chapter 4](#) and [Annex 401](#) of NAFTA). For the purposes of this determination, the reference to "territory" in the Rules of Origin must be replaced with "Canada".

- To determine if any product that is partially or wholly constructed from imported components meets the NAFTA Rules of Origin definition, the following steps could be taken:
 - 1) Determine the tariff classification number in the Canadian Customs Tariff Harmonized System that best reflects the final product for sale. The most recent Canadian Customs Tariff can be found on the Canada Border Services Agency website.
 - 2) Determine the tariff classification number(s) in the Canadian Customs Tariff Harmonized System that identify the imported component(s) used to construct the final product.
 - 3) Locate the tariff classification number of the final product for sale in NAFTA (see Chapter 4 and Annex 401). Use the definition provided to determine whether the changes to the good that took place in Canada are sufficient to qualify the final product as a Canadian good.
- Further information on the Rules of Determination, including examples, can be found in Annex 3.6 of the PSPC Supply Manual.

Question 6

Will Public Services and Procurement Canada (PSPC) determine whether my goods are Canadian goods?

Answer 6

No, it is the responsibility of the bidder to determine whether or not their goods qualify as Canadian goods.

Question 7

How do I certify that my goods are Canadian goods?

Answer 7

Per section 5.2.3.4, in order to certify that the goods being provided are Canadian goods, the bidder must complete the following statement by placing an "X" between the brackets, and including the completed statement with their bid:

The Bidder certifies that:

() the good(s) offered are Canadian goods as defined in paragraph 1 of clause A3050T.

The bidder's certification is subject to verification by PSPC and to audit.

Question 8

Where can I find additional information on the Canadian Content Policy?

Answer 8

Additional information on the Canadian Content Policy can be found in Section 3.130 and Annex 3.6 of the PSPC Supply Manual.

Question 9

If the product does not have a Drug Identification Number (DIN) but is approved under the current Covid-19 Interim Measure will that be acceptable?

Answer 9

Yes, wipes approved under the current Interim Measure must supply with their approval documents but would be accepted at this time.

Question 10

In regards to disinfectant wipes, are non-woven fabrics acceptable?

For example, Metrex Caviwipes, are in most hospitals but they are made from non-woven fabrics.

Answer 10

Yes, non-woven fabrics would be acceptable as long as they are ready to use and able to be sealed.

Question 11

Can we offer 1 gallon containers with empty (refillable) Flairosol misting bottles as the secondary aerosol container?

Answer 11

Yes, we can accept that format.

Question 12

Vital Oxide does not contain those ingredients but is still effective against Sars-Cov2. Would you consider our product in this tender?

Answer 12

Yes, chlorine dioxide, the active ingredient for vital oxide would be effective against SARS-CoV-2

Question 13

Apart from active ingredient mentioned in the list, are additional active ingredients allowed with those what are in the list?

Answer 13
