QUESTIONS AND ANSWERS

Question 1

We wonder if the contract will be given as a lot for the 3 ships or if they can be handled individually by 2 or even 3 different shipyards.

Answer : The goal of the bundling is to award the contract to one yard.

Question 2

In the Invitation to tender, under item 2.7, the dates for the work are indicated as below.

Work must commence and be completed as follows:

CCGS Caporal Kaebler V.C.

Start: December 19, 2020

End: January 30, 2021

CCGS A. LeBlanc

Start: November 3, 2021

End: December 8, 2021

CCGS Constable Carrière

Start: December 15, 2021

End: January 26, 2022

We can confirm that we are able to perform the work during these periods. However, can the release dates differ from the work completion dates depending on the ice conditions?

Answer : As stated at Section 11.1.E.3 of the Specifications :

"11.1.E.3 OPTION: The Contractor must provide a weekly price for storing the vessel in the event that it would be impossible to remove the vessel from the dry dock due to ice at the end of the work period. This price must include all costs."

MODIFICATION #1

Section "2.5 Bidders' Conference" of the bid solicitation is amended as follows :
