The following questions are being asked by potential bidder/s:

Question 1

RFP Section 3.2.4 "a) submit a maximum of two (2) c.v.'s of senior personnel." - Is 2 CV limit 2 CVs total for section? or 2 CVs per category of senior personnel in section (i.e., PM and Back-up PM; Lead Architect and Back-up Architect)?

Answer 1

Yes, 2 per category, example: PM and Back-Up, Lead Architect and Back-Up

Question 2

RFP Section 3.2.5 "a) submit a maximum of two (2) c.v.'s of project personnel which will perform the majority of the work resulting from the individual Call-ups." - Is 2 CV limit 2 CVs total for section? or 2 CVs per category of project personnel in section (i.e., Civil Lead and Civil Back-up; Structural Lead and Structural Back-up)?

Answer 2

Yes, 2 per category, example: Civil lead and Back-Up, Structural Lead and Back up.

Question 3

Please clarify SP 4 on page 18 of 110. Is the maximum limitation of expenditure exclusively the A & E fees for a call up or the Project Costs of an expenditure, inclusive of A & E fees as well as construction costs?

Answer 3

The max limitation is per individual call up including tax for A&E support, this does not include the cost of construction.

Question 4

For Section 3.2.5 its asking for "projects requiring a full scope of services for the Government of Canada

within a policing environment in accordance with the Required Services (RS) section". Would projects for provincial or municipal governments within a policing environment be acceptable?

Answer 4

Yes. Policing projects for Provincial/Municipal are acceptable projects.

Question 5

For 3.2.4 Senior Personnel Expertise and Experience we are being asked to provide in-house personnel for expertise in each area listed in the RS Section which includes Architectural, Civil, structural, Mechanical, Electrical, Sustainability/Energy Modeling, Cost Consultant, Fire Protection/Code, Interior Design, Commissioning, Telecom, Security, Cost Estimating, Acoustic etc. I'm not certain that there are any multidisciplinary firms that have all of these disciplines in-house. If we're an Architectural only firm are we permitted to carry a team of sub-consultants and specialists and include the C.V.'s for the respective disciplines in this section? In this section you're asking for a maximum of 2 CV's, but there are approximately 13 disciplines listed in the RS Section - this is confusing! (Note - on previous RCMP RFSO submissions for other regions the proponent was to be an Architect and background information of engineers/specialists were not required to be a part of the submission. Dependent on the nature of the callup the Architect went about assembling a team of sub-consultants as necessary).

Answer 5

The firm must be an Architectural firm; others can be sub consultants. CV's must be provided for each lead and each back up consultant. All consultants need to be identified that will be used for this call up.

Question 6

For 3.2.5 Similar to guestion 2 above, rather than listing in-house personnel are we permitted to carry a team of sub-consultants and specialists and include the C.V.'s for the respective disciplines in this section?

Answer 6

The firm must be an Architectural firm; others can be sub consultants. CV's must be provided for each lead and each back up consultant.

Question 7

For 3.2.5 2a it states – "submit a maximum of two (2) c.v.'s of project personnel which will perform the majority of the work resulting from the individual Call-ups". Given we don't know what the actual call-ups will be for, are there any specific disciplines these CV's should be from? Would it make sense to provide the c.v.'s for the architectural project managers likely to be assigned?

Answer 7

CV's must be provided for each lead and each back up consultant.

Question 8

Please clarify how the Technical Proposal and Price Proposal will be weighted. SRE 5 has % of total score as 70/30 while the Points score is 90/10?

Answer 8

As per SRE amended documents below.

Question 9

We would expect that this is to be a "quality based" selection process, however attributing 30% to fee is making this "Price based". We respectably request that the Price rating be reduced to 10 %.

Answer 9

As per SRE amended documents below.

Question 10

SRE 4 states that the lowest price gets 100 points, second lowest 80 points, third lowest 60 points etc. This does not appear to be a fair manner of scoring the fee as a price differential as low as \$1 dollar could result in a 20-point differential and conversely a differential significantly more substantial could also result in a 20-point differential. We therefore request prices be scored in a pro-rated manner against the lowest price. Also, given the Pricing Tables in Appendix B are arbitrary with respect to the hours allocated to particular disciplines, we believe pro-rating the scoring of fees would be a fairer approach.

Answer 10

As per SRE amended documents below.

Question 11

The Pricing Tables included in Appendix B requires fixed hourly rates to be provided for select disciplines. This list does not match the disciplines listed in Appendix C – Team Identification or the disciplines in RS Section. For items 1, 2 & 3 are we to provide blended rates for all Architectural & Engineering Disciplines even though they may be from multiple firms? Is the expectation that the all A & E firms adapt and apply the blended rates to actual call-ups should they be successful? This doesn't appear reasonable since the hourly rates between some disciplines/personnel can vary by upwards of \$100/hr. Perhaps this form should be revised to list all the disciplines individually?

Answer 11

Pricing is to be fixed for each of the noted years. It should be based on their costs to provide the service.

Question 12

Its noted that the proposal is to be limited to a maximum of 35 Pages however dependent upon the responses to some of our questions, please recognize more pages may be required. Please consider increasing or removing the page limit.

Answer 12

As per SRE amended documents below.

Question 13

Does "in a policing environment" refer only to police forces? We have completed large projects for

Correctional Services Canada (in prisons) and 4 or 5 projects for National Defence, including some where security clearances were required.

Answer 13

Projects must be policing type buildings can be Provincial/Municipal police buildings.

Question 14

In the Required Services section, are you referring to new constructions and/or renovations to existing buildings?

Answer 14

New construction and or major renovations or mid life refits.

Question 15

- a. What is a "significant project?" Is there a minimum construction budget so that our projects would be considered to be of a comparable size?
- Our projects referred to in No.1 above vary between \$7M and \$40M.

Answer 15

- a. Minimum project value must be 5 M to be considered relevant.
- b. Yes. That would be relevant as long as they are policing facilities.

Question 16

Do the projects we reference have to be completed?

Three of our relevant projects are still ongoing, but two of them are almost complete. Is the Certificate of Substantial Performance required?

Answer 16

Projects must be completed projects for relevancy.

Question 17

The tender is for architects and engineers: do we have to retain the services of engineers within our team? If so, for what disciplines? Structural, mechanical, electrical, civil? Are any other specialists required?

Answer 17

The firm must be an Architectural firm and others are identified in the RFP consultants do not need to be in house they can be sub consultants.
