(1) Bidders' Questions and Answers

QUESTION # 34:

The current situation with the COVID-19 had a major impact on all suppliers and production facilities throughout the country. Supplies in components and ammunition have been impacted, making it almost impossible to find the required ammunition. Accessibility to 100m firing range that would allow to fire over 12,000 rounds using a prohibited device is also a major setback in terms of logistics. For all the above-mentioned issues, and all other issues previously discussed in Amendment 009, we would request a minimum extension of 2 weeks in order to complete all the mandatory tests to provide a competitive solution to Canadian Forces. If this demand cannot be approved, it will automatically put us at high risk of not being able to provide a compliant submission.

ANSWER # 34:

Canada understands that there are challenges faced by potential bidders as a result of the COVID-19. In response to this bidder's request, Canada will extend the bid closing date by 14 days.

QUESTION # 35:
