Question 1: As regards the solicitation Part 2 – BIDDERS INSTRUCTIONS, how do you certify you are not a public servant?

Answer 1: Refer to the definition of a public servant in section 2.3. If you do not fit that definition, you just need to say you are not a public servant in your proposal.

Question 2: In Part 3 – BID PREPARATION INSTRUCTIONS, section 3.3.1.1 Financial Bid presentation sheet, it states: *Bidders must propose a firm all-inclusive hourly rate for each year of the contract and for each category including option years.* Is it okay to include the cost of acquiring computing, the maintenance of computing and travel?

Answer 2: As specified in section 3.3.1.1 of the RFP bidders must propose firm all-inclusive hourly rates which are inclusive of direct labour, overhead, and profit. As this is a contract for services, Canada will not pay for any equipment or supplies. Please see General Conditions 2040 05 (2012-03-02) – Conduct of the Work, specifically: *The Contractor represents and warrants that: b. it has everything necessary to perform the Work including the resources, facilities, labour, technology, equipment, and materials.*
Do not include travel in your financial bid, as we are not evaluating it in the proposal.
